

**Lake Carmel Park District**  
**Beach ID, Family Guest Pass, Visitor Parking and Replacement Fees**

All Lake Carmel Park District residents are required to have an official Lake Carmel Park District issued Photo ID to use the beach facilities. Children 12 and older may obtain photo IDs (with parent/guardian permission). To enter beach facilities, children under 12 years must be accompanied by an adult 18 or older with a park issued photo ID. Photo IDs are issued at the Lake Carmel Park District office.

**Note: First Issue of any of passes and stickers are free of charge.**

**Photo ID**

**Required documents:**

- **Homeowner:** Current property tax bill **and** Driver's License, Learner's Permit or State Issued Non Driver ID.  
Expiration: 4 year cycle
- **Renter:** Copy of lease agreement or letter from landlord with dates of occupancy **and** Driver's License, Learner's Permit or State Issued Non Driver ID.
  - Please keep in mind that if the homeowner has already obtained their beach passes, you are **NOT** eligible for your own. You may ask your landlord for their family guest pass.
  - Expiration: Dec 31<sup>st</sup> of year issued

If two families reside at the same address, you must show proof of legal two family residences (tax bill).

**Youth Applicant (12-17 years old) must provide proof of age:**

(Children 12-17 must be have permission of parent/legal guardian in order to obtain a photo ID)

- Birth Certificate or Passport
- Driver's License, Learner's Permit, or State Issued Non Driver ID

**Family Guest Pass (Visitor Parking Pass)**

- There will be only one family guest pass and visitor parking pass issued per household to the homeowner.
  - Renters may contact their landlord to request, only if the landlord will not obtain a family guest pass.
- Passes are applicable for a small car load of guests; every guest should fit comfortably into required seat belts of said vehicle.
- Family Guest Pass should be presented to lifeguard when requested. Visitor parking pass should be hanging from the rear view mirror of guest's vehicle in full view.
- Passes are valid for a 4 year cycle for homeowners (expire Dec. 31<sup>st</sup> of current year for renters if applicable).

**Replacement Fees:**

- Photo ID: \$ 35.00
- Guest Pass: \$ 50.00
- Visitor parking pass: \$ 35.00
- Boat: \$ 5.00/each boat
- Vehicle Stickers: \$ 10.00/each vehicle (If new vehicle is purchased, present old sticker for free replacement. If old sticker is **not** presented, replacement fee applies.)
