## RESTRICTED BURNING PERMIT CONDITIONS

The following information is the modified burning regulations due to some recent changes in the NYS –DEC laws (6 NYCRR Part 215). Open Burning Permit are no longer issued from a Forest Ranger office. Some other new changes are as follows:

- NO LEAF BURNING.
- No treated wood such as varnished, stained, sealed, glued or otherwise adulterated, pressure treated, plywood, particle board, fiberboard and oriented strand board (OSB)
- No branch larger than six (6) inches in diameter and less than eight (8) feet long
- No open burning at all from March 15<sup>th</sup>. To May 15<sup>th</sup>.
- No burning on Sundays or holidays
- No burning at all in the Lake Carmel Sanitation District. Grass and Leaf bags are available at the Sanitation Dept. located at 62 Ludington Court or call (845) 225-7030.

Burning Permits shall be issued only to those who reside outside the <u>Sanitation District</u>. This Permit is conditional. You further agree to the following conditions:

- Down tree limbs and branches less than six (6) inches diameter, less than eight (8) feet long with needles and leaf attach
- Burning is from sunrise to sunset.
- You must be there, at all times!
- You need water or a garden hose and hand tools (shovel, rake etc).
- Three (3) feet clearance, free of vegetation around a burn barrel and twenty-five (25) feet from a structure or three (3) feet clearance, free of vegetation around the small piles 50 feet from a structure
- Small piles should not be larger than three (3) feet in diameter by two (2) feet in height

You <u>must</u> call Kent Police Dept. at (845) 225-5646 and the Putnam Co. 911 Dispatch Center non-emergency at (845) 225-4860 <u>before</u> you burn. Permits are available from the Town Clerk's Office. If you have questions, you may call the Fire Inspector's Office at (845) 306-5599.
