## 2020 TRIP SCHEDULE

The Officers of the Senior Citizens of the Town of Kent would like to wish our members a Happy and Healthy New Year.

In order to qualify for the 2020 trips you must be a member in good standing and pay your yearly dues by the end of March 2020. Club dues are \$10.00 per person. (A member in good standing means you must attend at least three Sunday meetings per year in order to be eligible for member pricing on trips.) Dues are payable by cash or check made payable to the Kent Seniors and are accepted at the drop-in on Tuesdays or the Sunday Meetings (location St. James Doherty Hall – 14 Gleneida Avenue, Carmel, New York 10512).

Anyone becoming a member after March 31, 2020 will have to wait for January of the following year to be eligible for member pricing (after paying dues for that year). If you want to go on trips you will have to pay the non-member price. To become a member you must show proof of residency in the Town of Kent, (Driver's license, phone bill, electric bill, etc.).

Monies for the upcoming trips will be collected approximately two months prior to the scheduled trip. Members will have the first opportunity to sign up for trips. If there is any space left then non-members may sign up. Checks are to be made payable to the Kent Seniors. You can sign up as stated above - Tuesdays at St. James Doherty Hall or at the monthly Sunday meetings.

In case you have to cancel out of a trip, **DO NOT CALL ANYONE EXCEPT MARSHA KARL. Telephone #845-629-6345.** Please call between 6:00 PM and 9:00 PM. Marsha will deal with all trip requests should you need to cancel. 48 hours' notice is preferable. If Marsha can find a replacement for you, your money will be refunded. If no replacement can be found, you will not get a refund.

**All buses will leave from Kent Recreation Building (Old Kent Police Station), Route 52 & North Terry Hill Road.** Buses will leave promptly at the announced departure time. Please plan to be at the parking area at least one half hour earlier. (Example: Departure 8:45 AM – Arrive 8:15 AM). We must leave on time to remain on schedule and arrive at our destination at the appointed time.

Sunday meeting are on the third Sunday of every month with the exception of July and August. There are no meetings in those two summer months. If there is a holiday on that particular Sunday, a date change will be announced at the previous month's meeting.
