Subject: Paving Machine

Dear Supervisor Fleming and Kent Town Board Members,

I would like the Town Board to make a resolution to put the Highway 1985 Paving Machine up for auction. This piece of equipment will need to be replaced in the near future and will need major repairs soon. I want the Town of Kent Highway Department to be able to benefit from any revenue while the equipment still has life and value. The cost for a new equivalent model is in excess of \$350,000.00. I would like to have the revenue from the sale put in my equipment line and eventually purchase a smaller paving unit that will be better suited for our purposes.

We are the only Town in the Hudson Valley that does not sub out our road paving projects. The Town of Kent has only been averaging paving approximately 1.5 miles of road per year using our CHIPS Funds doing the work in house which is not acceptable in my opinion. That would mean that every 75 years residents can expect their road to be repaved.

Other surrounding Towns have seen a \$5.00 per ton savings by having an outside contractor do their paving projects which will free up our crews to be able to upgrade our drainage and do other needed projects throughout the Town of Kent roads.

<u>Highway #20</u> is a 1987 International 5000 Series 10 wheel dump/plow truck. The frame is rotted and too thin. It is unsafe and has reach the end of its service life. It will not pass NYSI.

Highway #105 is a 1989 Dodge 2500 Series pickup. It is rotted and rusted out. It has reached the end of its service life. Will not pass NYSI.

<u>Highway # 106</u> is a 1988 Chevy pickup. It has engine failure and the bed is severely rotted. It has reached the end of its service life.

<u>Highway #109</u> is a 1993 Ford F350 pick/up. It has major engine damage/front suspension damage/severely worn. It is rusted and rotted and has reached the end of its service life.

Highway #112 is a 1986 Dodge pick/up. It is rusted and rotted out. It has reached the end of its service life.

<u>Highway #44</u> is a 1997 Chevy 2500 Series pick/up. It has engine failure and transmission failure. The frame is rotted. It has reached the end of its service life. It will not pass NYSI.

<u>Highway #104</u> is a 201 Dodge 3500 Series pick/up. It has engine failure and the frame is rotted and thin. It has reached the end of its service life. It will not pass NYSI.

<u>Sanitation #19</u> is a 1997 Volvo. It is rotted and has reached the end of its service life. It will not pass NYSI.

Sanitation #15 is a 1995 Chevy 3500 Series. The frame is rotted. It has reached the end of its service life. Will not pass NYSI.

This is a list of vehicles that have been put out of service the last few years. We have kept and used them for spare parts to keep other town vehicles running at no cost. These vehicles are of no use to us anymore because we have used all necessary parts. We can now get money for these vehicles for their weight in scrap metal.

Subject: Additional Funds Needed for Equipment

Dear Supervisor Fleming and Kent Town Board Members,

I would like to again thank the Town Board for recently approving the purchase and refurbishing of equipment for the Highway Department. The Town Board Resolution to approve the purchase of the three pieces of equipment and having one piece of equipment refurbished was for a total of \$76,151.00.

The original quote received from Pine Bush Equipment for the Dyna Pac Roller was quoted under NJPA (National Joint Powers Alliance) Contract and approved for the sum of \$11,057.00. When we proceeded to order this piece of equipment it was determined that it was not eligible to be under the NJPA Contract therefore the current price for the Dyna Pac Roller is \$15,795.00 for a difference in price of \$4,738.00.

I was able to purchase the 18ft Heavy Duty trailer that had been approved for \$8,250.00 at a cost of \$6,741.00, for a savings of \$1509.00. However, the smaller trailer for the roller that had been approved for \$3,100.00 actually cost \$3,286.00 for a difference in price of \$186.00. The net savings including these two items is \$1,323.00.

Currently the total purchase price for the approved equipment and refurbishment will be \$79566.00. This breaks down as follows:

Dyna Pac Roller	\$15,795.00
18Ft Heavy Duty Trailer	6,741.00
Smaller Trailer for Roller	3,286.00
Refurbishment of Cat Loader	53,744.00
Total	\$79,566.00

After calculating the differences in pricing there is a shortfall of \$3,415.00 from the original Town Board Resolution and approval. Therefore we are asking the Town Board to revise the original Town Board Resolution to include the above and amend the total purchase price of the equipment and refurbishment from \$76,151.00 to \$79,566.00.

NEGATIVE DECLARATION

AMENDMENT OF EXISTING LOCAL LAW CHAPTER 66: STEEP SLOPE AND STORMWATER MANAGEMENT LAW OF THE TOWN OF KENT.

TOWN OF KENT, NEW YORK

WHEREAS, it is the intent of the Town Board of the Town of Kent to maintain minimum stormwater management requirements and controls to protect and safeguard the general health, safety, and welfare of the public residing within this jurisdiction, and, meet the requirements of minimum control measures of the SPDES General Permit for Stormwater Discharges from Municipal Separate Stormwater Sewer Systems (MS4s), Permit No. GP-0-10-002, as hereafter amended or revised; and,

WHEREAS, in order to meet the requirements of the minimum control measures of the SPDES General Permit for Stormwater Discharges from Municipal Separate Stormwater Sewer Systems, Permit No. GP-0-10-002 the following modifications to the existing Chapter 66 of the Town of Kent Town Code entitled, Steep Slope and Stormwater Management are required:

1: Section 66-4:

A: Existing Definition of LAND DEVELOPMENT ACTIVITIES:

Construction activity including clearing, grading, excavating, soil disturbance or placement of fill that results in land disturbance of equal to or greater than one acre, or activities disturbing less than one acre of total land area that is part of a larger common plan of development or sale, even though multiple separate and distinct land development activities may take place at different times on different schedules.

Change to:

Construction activity including clearing, grading, excavating, soil disturbance or placement of fill that results in land disturbance of equal to or greater than 5,000 square feet, or activities disturbing less than 5,000 square feet of total land area that is part of a larger common plan of development or sale, even though multiple separate and distinct land development activities may take place at different times on different schedules.

B: Existing Definition of SPDES GENERAL PERMIT FOR CONSTRUCTION ACTIVITIES:

A permit under the New York State Pollutant Discharge Elimination System (SPDES) issued to developers of construction activities to regulate disturbance of one or more acres of land, as hereafter amended or revised.

Change to:

A permit under the New York State Pollutant Discharge Elimination System (SPDES) issued to developers of construction activities to regulate disturbance of 5,000 square feet or more of land, as hereafter amended or revised.

2: Section 66-5:

A: Existing 66-5(A)(1): Any disturbance involving one or more acres of land;

Change to:

The regulations established in this provision shall apply to all land development activities of 5,000 square feet or greater and/or all land development activities that move 100 cubic yards or more of soil material, and/or 2,000 square feet or greater on steep slopes within the Town of Kent, including any activity not physically completed prior to the effective date of this chapter. As used in this section, the term "physically completed" shall mean the actual completion of construction activities related to a regulated activity, including filling, erecting structures or other improvement or development activities. Land disturbance does not need to be contiguous to be included in total area calculations.

3: Section 66-11

A:Existing 66-11 (C),(G),(H),(J),(K): All reference 1 acre.

Change to: All references of 1 acre are changed to 5,000 square feet

4: Section 66-14:

A: Existing 66-14(A)(2); Condition B: stormwater runoff from land development activity disturbing between one and five acres of land during the course of the project, exclusive of the construction of single-family residences and construction activities at agricultural properties, or;

Change to: Condition B: stormwater runoff from land development activity disturbing between one and five acres of land during the course of the project.

5: Section 66-14:

A: Add: 66-14(B)(11):. Land development activities as defined in §66-4 of this chapter that disturb one or more acres of land shall also include water quantity and water quality controls (post-construction stormwater runoff controls) designed in conformance with the enhanced phosphorus removal design standards in the most

current version of the technical standards of the New York State Stormwater Management Design Manual.

WHEREAS, the Town Board has determined that these modifications to the existing Chapter 66 in the Town of Kent Town Code entitled, Steep Slope and Stormwater Management Law will result in meeting the requirements of the minimum control measures of the SPDES General Permit for Stormwater Discharges from Municipal Separate Stormwater Sewer Systems, Permit No. GP-0-10-002; and,

WHEREAS, the Town prepared a short-form Environmental Assessment Form (EAF), dated and,

WHEREAS, the proposed action has been determined to be an Unlisted Action under the State Environmental Quality Review Act (SEQRA); and

NOW THEREFORE BE IT RESOLVED as follows:

Motion:

- 1. The Town Board has compared the proposed action with the Criteria for Determining Significance in 6 NYCRR 617.7 (c) and determined that the proposed action will not have a significant adverse impact on the environment.
- 2. The Town Board has considered all reasonably related long-term, short-term, direct, indirect, and cumulative environmental effects associated with the proposed action including other simultaneous or subsequent actions.
