Dear Supervisor Fleming and Members of the Town Board:

I am in receipt of a resolution by the Board of Trustees of the Kent Public Library, as well as a petition consisting of 112 pages and 981 signatures requesting that the following question be placed on the ballot to be voted on at the next general election:

SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF KENT FOR THE OPERATING BUDGET OF THE KENT PUBLIC LIBRARY BE INCREASED BY THIRTY NINE THOUSAND FIVE HUNDRED THIRTY SIX DOLLARS (\$39,536) TO THE SUM OF FIVE HUNDRED SIXTY SIX THOUSAND SIX HUNDRED EIGHTY SIX DOLLARS (\$566,686) ANNUALLY?

I have reviewed the Petition and verified 910 signatures as voters registered in the Town of Kent. I have also conferred with the Putnam County Board of Elections and been advised that ten percent of the votes cast for Governor by registered Kent voters at the last gubernatorial election equals 524 votes. Because the number of verified signatures on the Petition exceeds 524, I ask that the attached Resolution be placed on the Town Board Agenda for the July 2, 2019 meeting.

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE KENT PUBLIC LIBRARY

A meeting of the Board of Trustees of the Kent Public Library was held at 7 p.m. on the 18th day of June 2019.

The following Trustees were present, constituting a quorum of the Board: Michael Mahoney, Irene Rohde, Florence Ratti, Thomas Maxson, Jessica McMath, Martha Collins, Michael McDermott, Otto Romanino, and Kathryn D'Angio,

The following motion was made, seconded and unanimously carried:

WHEREAS, there has been presented to the Board of Trustees of the Kent Public Library a petition signed by qualified voters of the Town of Kent in a number exceeding ten (10%) per centum of the total number of votes cast for Governor in the Town of Kent at the last gubernatorial election, asking that the following question be placed upon the ballot and voted on at the next general election of the Town of Kent:

SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF KENT FOR THE OPERATING BUDGET OF THE KENT PUBLIC LIBRARY BE INCREASED BY THIRTY NINE THOUSAND FIVE HUNDRED THIRTY SIX DOLLARS (\$39,536) TO THE SUM OF FIVE HUNDRED SIXTY SIX THOUSAND SIX HUNDRED EIGHTY SIX DOLLARS (\$566,686) ANNUALLY?

and

WHEREAS, the endorsement of this Board of Trustees of the Kent Public Library is required before such question may be placed upon the ballot

NOW, THEREFORE, BE IT RESOLVED, that this Board of Trustees hereby endorses the petition presented to it and directs that the following question be voted on at the next general election of the Town of Kent:

Certification of the Proposition by the Town Clerk to the Board of Elections is a "mandatory, nondiscretionary action." <u>Id.</u> at 806; <u>see also Matter of Rose Memorial Library Association v. Skinner.</u>, Index No. 034595, Sup. Ct., Rockland County. (September 29, 2017, Eisenpress, J.) (directing the town clerk to certify and transmit the proposition contained in the petition filed with her to the Board of Elections for placement on the general election ballot). The Town Clerk is required to certify the Proposition to the Board of Elections no later than August 5, 2019. Election Law § 4-108(1)(b).

The Library indicated that one or more members of the Town Board suggested that the Town Board might increase its appropriation to the Library if the Library would withdraw the petitions. More than 900 Town voters have expressed their interest in having the Proposition on the ballot at the 2019 General Election, however, and the Library Board of Trustees has already endorsed the Proposition and transmitted it to the Town Clerk. Even if the Library Board of Trustees were able to ignore its own prior determinations, it would be ill-advised to disregard the will of so many voters who have expressed their support for the Library.

I hope the Town will move the Proposition forward without any further delay. Please contact me if you have any questions or concerns.

The Town of Kent has found it necessary to require that property owners maintain their septic systems (also known as separate sewage disposal systems/on-site sanitary systems) properly to prevent possible hazards to public health, minimize potential failure and protect the water supplies in the Town of Kent.

The Town of Kent Code specifies in Section 60-3 that:

Beginning on May 1, 2011, the owner of any parcel located within the Town of Kent which relies upon a separate sewage disposal system/on-site sanitary system shall cause an inspection to be performed on said separate sewage disposal system/on-site sanitary system at a minimum frequency of once every five years.

Your local septic company performs these inspections. Upon the completion of any inspection, the septage hauler will furnish a copy of the inspection report to the Town's Code Enforcement Officer, a copy to the Putnam County Health Department and a copy to you, the homeowner. You are required to maintain a copy of the report for a minimum of six (6) years.

Failure to have your system inspected is a violation of the Town Code and may subject you to penalties.

If you have not had your septic system inspected in the last five (5) years, please do so to protect our water and to avoid penalties.

1. Stabilization Inspection:

A stabilization inspection was conducted for this project on December 19, 2018 with Bruce Barber and Jamie LoGiudice of Insite. Sit fence and other temporary erceion control measures had been removed.

The previously disturbed area is now considered fully stabilized in accordance with NYSDEC SPDES General Permit for Stormwater Discharges from Construction Activity Permit No. GP-0-15-002.

2. Notice of Termination (NOT):

Submitting the completed NOT (including completed MS4 sign-off on Page 2) to NYSDEC will close-out coverage under NYSDEC GP-0-15-002 and the Town of Kent Erosion Control Permit. Having the 'Qualified Professional' sign the Notice of Termination fulfills the requirement per Town of Kent Town Code, Chapter 68, §68-6.K(5) for a certification of completion of work.

A NYSDEC Notice of Termination (NOT) form was submitted by the applicant to the Town. The 'Qualified Professional' signed the NOT to fulfill the requirements of §66-6.K(5).

3. Erosion Control Bond:

Per Chapter 66, §66-7.A(2) regarding return of the erosion control bond: "The security shall remain in full force until the applicant and/or developer is released from liability by the Town, provided that such period shall not be less than two years from the date of final acceptance..."

The site achieved final stabilization as of the December 19, 2018 inspection. The two-year waiting period began on 12/19/2018.

For other single-family home projects, the Planning Board has reduced the two year waiting period for bond return. If the Planning Board is considering a bond reduction, our recommendation is for the erosion control bond be held for at least one year to ensure the vegetation survives at least one winter.

4. Certificate of Occupancy

At the time of the stabilization inspection in December 2018, the single family house and separate art studio had not been granted certificates of occupancy. Typically, the CO's have been granted prior to Notice of Termination sign off request. Since that time, the certificates of occupancy have been granted. The Building Inspector confirmed the area of disturbance was still regetated.

5. Permit Close-out

Based on the stabilization inspection in December 2018 and completion of the work since then, attached hereto is the fully executed Notice of Termination. As the vegetation (grass) survived the winter, we have no objection to the Planning Board reducing the two year waiting period for release of the \$5,100 erosion control bond.
