

TRAILER MATERIAL

The trailer material shall be constructed of 2 in. \times 3 in. \times 1/8 in. (51 mm \times 76 mm \times 3.175 mm) steel tubing. All steel surfaces shall be powder coated highway safety orange (other colors available). The powder-coated paint shall be certified UV protective paint and shall be impact, humidity and salt spray resistant. Fenders shall be a durable composite material that can be easily replaced if damaged and shall be black in color. The composite fenders shall be rated at 250 lb. for standing.

SIGN BOARD

The sign board material shall be constructed of aluminum and powder coated black. The powder-coated paint shall be certified UV protective paint and shall be impact, humidity and salt spray resistant. The bottom of the sign board, when raised for operation, shall be seven (7) feet above the ground. The sign board shall pivot and be lockable in any position using a band brake design, with 360 degree rotation about the vertical axis in a clockwise or counter clockwise direction. The face of the sign board shall be a UV stabilized, seamless, impact resistant anti glare polycarbonate protective screen. The entire unit shall be protected by a weatherproof and lockable vandal resistant enclosure that affords easy access for maintenance and includes hinges and gas springs that lock when open.

CONTROL CABINET

The control cabinet shall be NEMA TYPE 4 rated and made of steel. The entire unit shall be protected by a weatherproof and lockable vandal resistant cabinet door. The control box shall be located at the back of the sign board and shall house the V-Touch controller to create and edit messages.

BATTERY BOX

The message sign shall have one battery box. The battery box shall be a durable polyethylene composite material and be UV stabilized to prevent fading and cracking. The battery box shall be approximately 34 5/8 in. (879 mm) long, 21 5/8 in. (549 mm) wide and 13 ¼ in. (337 mm) high. The battery box lid shall be reinforced with six cone shaped stanchions and should be strong enough to stand on. The battery box shall have holes for venting and draining and house from (2-6) 6-volt deep cycled batteries

DISPLAY

The display shall be full matrix type (48×80 pixels) with up to 5 lines of 13 characters per line using the default character. A character is based on a 5×7 pixel of 4.29 in. (109 mm). Each pixel shall consist of 1 equally spaced LED. The color emitted by the LED shall be amber, with a peak wavelength centered at 590 (+/-3) nanometers. The LED output shall adjust automatically to ambient light conditions. The characters cards shall be securely fastened with screws but quickly removed and have a plug and play connection.

POWER SUPPLY

The message sign shall operate primarily from a solar powered electrical system that consists of a battery bank and high efficiency solar panel arrays. Solar and battery arrays will differ per region. The unit shall have an MPPT solar regulator to maintain and manage the charging of the batteries from the solar array and provide battery surcharge protection. The solar panels shall be high efficiency polycrystalline silicon solar cells and anti-reflection coated for improved efficiency. The batteries shall be 6-volt 220 amp/hour deep cycled batteries wired to provide a 12-volt system.

COMMUNICATION

The unit shall come with a 3G/4G LTE DIGI modem with built-in GPS for remote communication with the sign. Having a modem on the unit allows the users to get access remotely to our JamLogic Fleet Management Software. JamLogic allows the users for instance to create messages, edit messages, shedule messages, manage and monitor signs (via modem) from PC, laptop, tablet and smartphone.

SOLAR PANEL ASSEMBLY

The solar panel assembly shall have the ability to tilt and rotate to maximize the exposure to the sun. The solar panel assembly shall tilt up to a 60 degree angle, rotate 360 degrees around a center axis and have a locking mechanism to securely lock the assembly in place.

CONTROLLER

The NTCIP compliant controller shall be a 7-inch (178 mm) color, LCD, pressure sensitive display screen. All message editing, scheduling, diagnostics and all other functions shall be completed by touching the icons and keyboard on the 7-inch display screen. LIFT MECHANISM

The mast assembly shall include a manual winch to raise and lower the signboard and hold it securely in place, with the bottom of the sign 7 feet above the ground.

Each corner of the trailer shall be fitted with four (4) galvanized crank and swivel type screw leveling jacks having a 907 kg (2000 lbs.) minimum capacity; maximum of 15 in. 

Can you put this on the next Town Board meeting for you guys to sign off on. This is for the roof on the salt storage area & the concrete mafia block material storage bins.

Concerning both structures, I was verbally told by the DEP & Dec to bury these block 2' into the earth & tidy up the yard. The term "good housekeeping" was given & simultaneously apply for the variance as these issues were addressed. Previous to this, the salt was uncovered & was stored between block just lying on the surface. Salt was thus able to migrate freely towards the reservoir because it was not locked in. It was the same situation for our dirt & milling debris stored in the yard, they were just free lance piles all over the place which was just ridiculous.



TOWN OF KENT AMENDMENT TO CHAPTER 14 OF THE KENT TOWN CODE

BE IT ENACTED by the Town Board of the Town of Kent, Putnam County, New

York, as follows:

Section 1. A new Article IV entitled "Ancient Subdivisions" shall be added to

Chapter 57 regarding "Roads and Roadways" to read as follows:

§57-31. Purpose and Authority.

- A. Municipal Home Rule Law§10(1)(12) authorizes the Town Board to adopt local laws for the protection, order, conduct, safety, health and well-being of persons or property within the Town of Kent. In furtherance of such goals, all roadways in the Town of Kent should be maintained at all times in the best interests of the health, safety and general welfare of its residents and others who travel along the roads within the Town of Kent, including roads which have been dedicated to the Town as well as certain private roads which have not been dedicated because they cannot be accepted by the Town as they do not comply with current minimum road standards.
- B. Town Highway Vehicles regularly traverse private roads, commercial and public connector roads and parking lots in order to expedite plowing efficiency, and this established practice benefits all Town residents.
- C. There are three subdivisions within the Town of Kent that were created prior to the advent of the Town Zoning Board of Appeals, the Town Planning Board and all zoning laws, including the Town zoning ordinance, and were therefore not subject to modern zoning laws and as a result, the roads within these subdivisions were constructed to widths which are below minimum acceptable standards for traffic. Therefore, the Town of Kent cannot accept these roads as "Highway by Use" because of the substandard condition of the existing roads.
- D. Private contractors have been unable or unwilling to maintain these roads so that they are accessible and passable during all times, particularly emergency situations and inclement weather, and the Chief of Police, the Kent Fire Department, the Lake Carmel Fire Department and the Department of Environmental Conservation all require the roads in these three subdivisions; namely White Pond Colony, Sedgewood Club and Hill & Dale County Club (the "Ancient Subdivisions") be accessible at all times for emergency situations.
- E. The Town of Kent adopted an Ancient Roads policy on March 7, 2018, authorizing the Town Highway Department to maintain and repair certain private roads.

§57-32. Agreement.

- A. The Town Board is hereby authorized to enter into a written agreement with each of the Ancient Subdivisions to permit the Highway Department to perform the following services:
 - 1. Remove fallen trees from the roadways.
 - 2. Patch potholes on an emergency basis.
 - 3. Plow and sand roads during inclement weather.
 - 4. Perform such other services as necessary to maintain the roads in the ancient subdivisions so that emergency services and school buses have access to those roads at all times, the cost of materials to be reimbursed.
- B. The costs for materials will be paid to the Highway Superintendent prior to the performance of any repairs in order to ensure compliance with the New York State Constitution's restriction of gifts of public credit to private entities.
- C. The costs for the use of Highway Department machinery and labor have already been paid by the residents of the Ancient Subdivisions in taxes which are paid by all Town residents.

Section 2. This local law shall take effect immediately.

- 4) ALL GRIEVANCE CHANGES, CORRECTION OF CLERICAL ERRORS, & UNLAWFUL ENTRIES SHALL BE APPROVED BY THE BOARD OF ASSESSMENT REVIEW AND ENTERED BY THE TOWN INTO THE REAL PROPERTY SYSTEM, BACKED UP AND BROUGHT TO THE REAL PROPERTY TAX SERVICE AGENCY NO LATER THAN JUNE 14th. FOR FINAL ROLL PROCESSING.
- 5) ALL CHANGES FOR THE SCHOOL TAX PROCESSING SHALL BE SUBMITTED BY AUGUST 2nd.
- 6) ALL CHANGES FOR COUNTY AND TOWN TAX ROLLS SHALL BE SUBMITTED BY THE TOWN ON OR BEFORE **NOVEMBER 15th.**
