#### **Short Term Rentals Discussion**

Supervisor McGlasson said discussion began a few weeks ago with the circulation of code from Pawling, in the backup tonight is code regarding short term rentals from Putnam Valley. Councilman Ruthven said he needs to review their code and sit down with our attorney for the best options for Kent; what are we looking to achieve, we know the problem. Councilwoman Campbell thought it would be helpful to hear from a community that has had this in place for a while. Town Counsel Tagliafierro said for Pawling it has worked out, there are parts of Pawling where the homes are very desirable to stay in, they have been able to monitor how many people are in the homes for safety reasons and the other bonus having a registry is when there is a problem there is a contact, this all goes through the Building Department. Kathy Doherty asked if the fees received from the registration will cover the cost of the employee to monitor them. She said we have current problems with our code, she has chickens and ducks next door to her and they are not permitted, and how will this do in court. Frank Smith, an attorney with Shilling and Smith explained in 2019 New York State changed laws related to the notice given for evictions. He said ordinarily it could be bargained in a lease now it is based upon the time of occupancy, if someone is there 1 year or less they get 30 days' notice. If they have been there between 1 and 2 years they receive 60 days' notice and if more than 2 years they receive 90 days' notice. He said in the instance of the squatters known as a non-landford tenant eviction, as a property owner you do not have a relationship with that person and can give a 10 day notice after if they do not vacate you can bring a summary proceeding to the local justice court. In our county we deal with people who stay in the residence after foreclosure. There is a post foreclosure eviction process, a 10 day notice served, if not out you go before the courts. Frank said there is no STR Law in the Town of Kent, the current Home Occupation Zoning Code refers to tourist homes which in an undefined term it is unclear what a tourist home occupation is. He said he has a client Nicole Glassman who resides at 2 Woodland Drive, he is scheduled to appear in Town Court for an illegal tourist home. He is prepared to try the case and believes it cannot be prosecuted. He said people like to visit our area, beyond visiting they bring revenue and there is nowhere to stay in Putnam County, if family visits and you do not have the space they will have to stay in Danbury or Fishkill. He said at present short term rentals are unregulated, the town only becomes aware of them through complaints or going on the short term rental websites. He said there are pros and cons, he believes the best way forward is to regulate it and put into code. He would like to see legislation created, it can safeguard the community, all is up to code, a mechanism to reach someone who is registered, and a means of creating revenue. He thinks it would clean up the issue of having no regulations, rectify the undefined tourist home angle and provide visitors, family the ability to spend time and money. Kathy Doherty suggested looking at different districts, in Lake Carmel the homes are on top of one another. Supervisor McGlasson said this discussion will continue to the first meeting in May. Councilman Boyd said Bob Bradley former ZBA Chairman, President of Plan Kent and Local Realtor could not be present but provided a statement on STR (attached).

WHEREAS, a project for the Nimham Road Over Seven Hills Lake Outlet Culvert Replacement-Town of Kent; Putnam County, P.I.N. 8763.25 (the "Project") is eligible for reimbursement of qualified costs from Bridge NY funding that calls for the post reimbursement of qualified costs to be borne at the ratio of 100% Bridge NY funds and 0% non-Bridge NY funds; and

WHEREAS, the Town of Kent will design, let and administer all phases of the Project; and

**WHEREAS**, the Town of Kent desires to advance the Project by making a commitment of 100% of the costs of design, right-of-way, and construction work for the Project of portions thereof.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board of the Town of Kent, duly convened, does hereby approve the Project; and

**BE IT FURTHER RESOLVED**, that the Kent Town Board hereby authorizes the Town of Kent to pay 100% of the cost of design, right-of-way, and construction work for the Project or portions thereof, with the understanding that qualified costs will be reimbursed from Bridge NY funding; and

**BE IT FURTHER RESOLVED**, that the sum of \$1,270,025 is hereby apportioned from the Town of Kent General Fund and made available to cover the cost of participation in the above phases of the Project; and

**BE IT FURTHER RESOLVED**, that the Kent Town Board hereby agrees that the Town of Kent shall be responsible for all costs of the Project, including costs which exceed the amount of reimbursement available from the NY Bridge Funding awarded to the Town of Kent; and

**BE IT FURTHER RESOLVED**, that in the event the costs of the Project exceed the amount appropriated above, the Kent Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification of the Supervisor thereof; and

**BE IT FURTHER RESOLVED**, that the Kent Town Board hereby agrees that the Town of Kent hereby commits that construction of the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months; and

Othmer, Jr., be and is hereby authorize to execute all necessary agreements, certifications or reimbursement requests with NYSDOT for State Aid and/or Bridge NY funding on behalf of the Town of Kent in connection with the advancement or approval of the Project and providing for the

administration of the Project and the municipality's funding of the Project costs; and

Sue Kotzur said the bridge on Nimham is a one way bridge. She would like to see the plans before it is put in and thinks some of the other residents would like to have some say and talk about it before it is constructed. Highway Superintendent Othmer replied the bridge must meet NYS and NYSDOT standards, it must be a two lane bridge in order to receive funding, you cannot build a 19<sup>th</sup> century bridge it must accommodate fire, concrete, oil trucks, he said it is out of his hands. He said we may have a say on how it looks but must be built to modern standards. Sue Kotzur said the 19<sup>th</sup> century bridge has been in use for many years she said fire, concrete, oil and logging trucks go over the bridge it is the people that bang into the bridge that are compromising the bridge. She said it is a quaint little bridge and does not want to see it go into a two lane bridge. She would like to see documentation stating it must be a two lane bridge. Highway Superintendent Othmer replied it must be a two lane bridge by law.
