Councilwoman McGlasson said Solitude is offering different options. Supervisor Fleming thought the ideal way to treat blue green algae is with Cutrine Ultra. Councilman Huestis questioned The Pond and Lake treating half the lake at first. Supervisor Fleming replied that's how it was done last summer, they treated the beach areas solving the problem, and we did not need a second treatment. Councilman Ruthven asked if we used cooper sulfate last year. Supervisor Fleming replied no; in the past when we needed a third treatment copper sulfate was used. Councilman Ruthven said Lake Carmel has no vegetation left at all and is unhealthy for the eco system; we need to try to get healthy weeds back into the lake. Walter Recher said the advisory board was considering consulting with Bruce Barber to look at mitigating phosphorus to the lake minimizing fixing it with treatments. Bobby Ulich brought to the board's attention that the second quote is actually cheaper than Mark Roland's quote. He feels the quotes are not comparing apples to apples. He thought we need to act quickly to obtain a permit. Supervisor Fleming explained Mark Roland applied for the permits, which comes to the town. This item was held over to the first meeting in June.

She also spoke to the Police Chief who will be enforcing social distancing. He expressed concerns about having them on June 27 citing the following concerns: the impossibility of enforcing social distancing and wearing face masks; if other displays are cancelled more people will flock to Kent; if people just stay in their cars to avoid other people it will create major traffic problems. Councilman Ruthven thought the Chief's recommendation should be taken seriously even though emotionally he thinks we need this. Councilman Denbaum thinks it is a mistake, he said the Governor has opened NYS beaches he would like to see what happens, he thinks everyone has to make their own decisions, the lockdown has had serious effects on all of us. He said at some point you have to allow people to go outside and look at the sky, we are no worse in Putnam than other regions. Councilman Ruthven explained beaches are open at 50% we cannot control the fireworks at 50% capacity, he wants to have them but just because he wants to have them is not the reason to go against the Executive Order it cannot be enforced. Councilman Denbaum thought it crazy that we are not having an outdoor even, we are taking this too far, and he is taking this serious. Councilwoman McGlasson thought people do need the fireworks but she did not think it realistic to have them but postponed until September it is not an easy decision it is a call that no one want to make. Councilman Huestis said even if we said yes we have to raise funds everyone is having a difficult time, he understands Paul but thinks it should be postponed. Councilman Denbaum understands everyone's concerns his frustration is the decision making process on the basis of experts that are ruling us and driving our local economy and our local communities to the ground.
