## Resolution#282 Open Public Hearing

On the motion by Supervisor Fleming Seconded by Councilman Huestis Resolved: Public hearing on extension of mining moratorium be opened at 7:10 p.m. Motion carried unanimously

Supervisor Fleming opened the public hearing stating that that on March 3<sup>rd</sup> the town board adopted Local Law #1 prohibiting mining in the Town of Kent for a six month period effective from the date of the local law. In the midst of a pandemic it was difficult to work on the mining legislation. This might take longer than six month but we were enthusiast thinking we could but clearly this was not the case. What we are proposing now is another local law extending the moratorium for another six months. Get the public's input and come up with a local law or a code change that addressing the mining in the Town of Kent to benefit our residents. We put this on for tonight because the moratorium expires on the 3<sup>rd</sup>. She thinks she speaks for the entire board that we are all in favor of extending the moratorium. Councilman Ruthven stated his only concern is that we are still in Covid. What is our plan over the next six months if we are still stuck in limbo? Councilwoman McGlasson stated that we can meet more in person than we could a few months ago. Councilman Huestis stated there is a task force to create, a committee, involve engineers and there are probably other communities that have similar legislation that we could replicate. Supervisor Fleming stated that when we can't have large gatherings the public can still contact us through email or regular mail. Councilman Ruthven stated that he volunteers to get a group together to start getting this ball rolling. He would like to see some progress. Supervisor Fleming stated that's great and he is the one who first presented to the board legislation from another town. Councilman Denbaum stated that the last time we had a Master Plan was 2008 and we are due for that. We could use this as a platform to get a new Master Plan going. He knows there are residents who would love to be involved. The Master Plan could address a lot of issues and we are due and there are a lot of issues that never got resolved from the last time. Councilman Huestis stated one problem is logging, lots of the roads out in western Kent can't take the weight. A master plan needs to be looked at every ten years, things change and we need to stay on top of it. We are working on the mining right now because that's a hot topic but our goal is to work on the master plan. Kathy Doherty asked Councilman Ruthven when he puts the task force together will the meetings be at the planning board? Councilman Ruthven stated it will be with the town board and we will use some of the consultants from the planning board. Mrs. Doherty asked how many more extensions can we get if we go past the six months. Counsel Tagliafierro stated one more. Walter Rechter stated he heard mention of a Master Plan and wonders how this fits into it. When was the last master plan done and how often should one be done? He would think that would be a priority on some level. The public at large sometimes wonders why some decisions are made because they don't see how it fits into a plan of some sort. Councilman Huestis stated he believes 2008 and he doesn't know the one before that. Every ten years we are supposed to look at and amending where there is an issue. The mining issue needs to be looked at sooner than later before the master plan.

He had it difficult trying to come up with ideas to deal with recreation. He is now giving reports and doing the best he can. He does not feel the same about pushing opening.

Supervisor Fleming: yay, stated sports program were cut and children do not have a lot of opportunities and he was creative to come up with other ideas. There have been hikes and online programs, on line Zumba and Trivia night, the soccer issue came to the board and was a hard choice. Jared has done a lot of things, improving the pump track, making the trails, he has come up with a lot of ideas. Motion carried.

### Public Comment

Councilman Denbaum stated the Carmel Central School District is delaying their in person learning. His kids go to St. James but if his kids went to the Kent Elementary school and he paid \$10,000 in taxes and my neighbors in Putnam Valley who live a couple miles away are sending their kids to elementary school every day of the week and my kids were home a) jeopardizing the education and the health of my kids just from being home all day and also making it harder to keep a job during this time I would be furious. There is no real reason the Carmel Central School District gave for the two week delay. There has been no health crisis, there has been no bump and we have not shut down everything. There is no reason other than an absolute lack of planning and lack of preparation to get things moving on time. Everyone likes to say health and safety and we have a moral obligation to make sure. What gets missed is the moral obligation to kids with special needs who are in our district who will be suffering for another two to three weeks if not longer without services. The moral obligation to all of our kids to get back into the classroom and learn safely. And the idea that Carmel Central School District cannot do it but neighboring school districts literal the town next door can. It isn't a health issue or a safety issue it's an incompetent issue. In the Putnam County Times from last month Carmel Central School District was going back and forth about their transportation building and were debating whether they should have an SRO in the school district and who should pay for them. The school district raises our taxes millions of dollars every year and is literally complaining about a couple of thousands of dollars in sheriff cost to protect our kids. Five weeks before they are supposed to have the kids go back to school and we find out a week ago oh we aren't ready to have the kids back to school. They are doing all the little pet projects, wasting all of our tax dollars at the expense of our children. He wishes he was able to set it up, he would invite anyone for the Carmel school board or the administration to come in and let the residents know why it is that Putnam Valley can go back with their elementary kids and kids with special needs in Putnam Valley and get their services but not the case in Carmel. They will do what is in their interest, what they want to do and not what is best for the kids.
