The Town of Kent regularly scheduled meeting was held on Tuesday, December 15, 2020 at 6:00 p.m. via ZOOM. The public was able to participate via Zoom, You Tube or by emailing comments to the Supervisor. Supervisor Fleming explained the town board decided to conduct meetings in this matter to keep the town moving until we get back to normal.

Mining Discussion

Supervisor Fleming read language provided by Councilman Denbaum to add a subsection to Chapter 63: Notwithstanding any subsection of this Chapter of the Town of Kent Soil Removal Law, no permit shall be issued for the removal of soil outlined herein if the amount of soil to be removed from the property at current cubic yards and the property is zoned commercial or the soil removal is in furtherance of a commercial use. Town Counsel Tagliafiero explained the DEC regulates the activity of mining for certain amounts over 750 cubic yards. The Town regulates issues that affect the health, safety and welfare. We cannot regulate soil dept or removal unless it can be related to a health, safety and welfare issue. Councilman Denbaum understood permits are issued by DEC but the Town can regulate its land use development. He said we have language pertaining to SEQRA and a moratorium to stop it until we are able to regulate it. Town Counsel replied we are able to regulate certain things and where is one. Many towns have a ban throughout the town on mining. Supervisor Fleming said Southeast and Putnam Valley have no prohibitions on mining. Patterson does with the exception of Peckman who has been grandfathered in, which is purely mining. She said Carmel might have some provisions we might be interested in; landfill grading and excavation, no operations shall be commenced or carried on which is primarily for the purpose of the sale or exchange of excavated top soil, earth, sand, gravel, rock or other substance from the ground, it goes on to say a building permit for excavation provided that the volume of any excavated material removed from the property does not exceed two times the volume of the cellar and the foundation of the dwelling or accessory structure for which the permit was issued. She thought Kent wants to control the amount that leaves related to what is being built. Councilman Denbaum explained if a full prohibition is in place you need a measure to apply for approval to vary which our soil law has. He prefers keeping it broad, the more detailed site requirements in the law the more opt the town board will defer to the Planning Board and experts to make the decision. He said the residents want their elected representatives to make the decision. Councilman Ruthven questioned how the project on Old Route 6 is getting around Carmel's Code; it is clearly a rock mining operation. Supervisor Fleming said in order to build in some locations we have to understand that rock will have to be removed. She asked Counsel when revising the code we cannot state the depth, but can say you cannot go as deep as you want because it is problematic for residents. She replied yes, and we can do as we want in areas excavated under the 750 cubic feet. Supervisor Fleming agreed with Paul, making additions to our Soil Removal Code. We do not want a floating mining zone, we want no mining, if you want to excavate because you are building something it has to be within certain parameters. Councilman Denbaum suggested instead of a sentence a few paragraphs be added

to our Soil Law, taking his language, what has been discussed, finding the weakness in Carmel's code and draw a draft we can agree upon. The board was in agreement.

Eileen Civitillo said earlier in the year we saw that Kent residents had strong opinions on issues that affect the health, safety and welfare of its residents. She asked if we can have a law that allows the residents to speak on projects. Town Counsel replied the public gets the opportunity to speak when there is a public hearing. She raised concerns anything written will be finagled. A discussion took place on residents input, ways to include it, a vehicle by which residents could be informed, if a permissive referendum could be included in a provision for approval allowing residents opportunity.

Sue Kotzur liked the direction this is going. She likes the public input and moving forward.

Supervisor Fleming advised the mining discussion will be placed on the second meeting in January.

<u>Authorizing Amendment to Lake Carmel Park District Advisory Committee By Laws</u>

Councilwoman McGlasson said some minor changes to the By Laws have been proposed by the LCPD Advisory Committee. The board discussed Item #4 and #13 and determined different verbiage would be proposed and introduced at the next meeting.
