She said there is a website, you click on Kent or Carmel, upload a photo either in their military uniform or a regular picture, they can be living or deceased, it is a way to honor our Veterans who have served for our freedom every day. She said it is going to be beautiful, the price is \$200.00 which includes a donation to various local Veteran Organizations. WHEREAS, by letter dated April 16, 2021, the Town Board of the Town of Kent has received a request from the Town Highway Superintendent to trade in Highway Equipment #76 2016 E-85 Bob Cat Excavator ("Highway Equipment #76); and

WHEREAS, the Highway Superintendent has recommended the purchase of a 2021 E88 R2 Series Excavator to replace the Equipment; and

WHEREAS, the Town Board has been provided with a proposal for one 2021 E88 R2 Series Excavator pursuant to a contract with the Bobcat Company at a cost of \$89,975.20, less the trade in value of Highway Equipment #76 for a cost of \$40,000; and

WHEREAS, Section 103(16) of the General Municipal Law exempts from competitive bidding

purchase contracts for apparatus, materials, equipment and supplies, through the use of contracts let by the United States or any agency thereof, any state or any other political subdivision or district; and

WHEREAS, in accordance with the Town's Procurement Policy and the General Municipal Law, the Town Board wishes to authorize the Highway Department to purchase the 2021 E88 R2 Series Excavator consistent with the above referenced proposal;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby authorizes and approves the trade in of Highway Equipment #76 and purchase of the 2021 E88 R2 Series Excavator for a price not to exceed \$49,975.20; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Kent hereby authorizes and directs the Supervisor to execute any and all documents necessary to give effect to this Resolution. Motion carried unanimously

Resolution #163 - To Hire Seasonal Park Maintenance Workers for Lake Carmel Park District

On a motion by Councilwoman McGlasson Seconded by Councilman Ruthven

WHEREAS, the Town of Kent is seeking to fill vacant positions for Seasonal Park Maintenance Workers for the Lake Carmel Park District ("LCPD"); and

WHEREAS, Frank Sabatini, Lake Carmel Crew Chief, has recommended the hiring of Sean Ferris for a six (6) month position at \$15 per hour from beginning immediately, through and including October 29th; Joshua Garrett from mid-May through and including September 3rd at a rate of \$12.50 per hour; and Abilio Saraiva Rego from mid-June through and including September 3rd at the rate of \$12.50 per hour to fill the seasonal positions; and

WHEREAS, the Town Board wishes to accept the recommendation of Mr. Sabatini and hire Mr. Ferris, Mr. Garrett and Mr. Rego;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby authorizes the hiring of Mr. Ferris, Mr. Garrett and Mr. Rego, as Seasonal Park Maintenance Workers for the LCPD as further detailed above.

Discussion Canada Goose Population in Lake Carmel Park District

Chairman of the Lake Carmel Park District Walter Recher explained they have been working on a Master Plan for the Park District. He read a statement from the Advisory Board and concerned residents recommending a comprehensive plan to reduce the population of Canada Geese around the shoreline. Based upon their observations as of Fall 2020 the number has tripled to at least 125 becoming an important issue. He said according to the USDA the average goose deposits on average 1.5 to 2 pounds of fecal matter per day. They also contribute on average 250 pounds of phosphates a year. The population has inhibited the use of amenities and contributed to green algae blooms and potentially carrying disease and created a nuisance to the residents. He said the board has a responsibility to its residents and park crew and would like the Town Board to engage with the USDA Wildlife Management Service in the development of a Comprehensive Plan to reduce the population of Canada Geese. Once a study is undertaken, they would like to begin their recommendations: 1. To continue addling the Canada Geese eggs to reduce the population. 2. Grow buffer zones around the lake to discourage their appearance in beach and park areas. 3. Hazing, bringing in dogs to scare them away. 4. Culling having the population removed around the lake and being processed and donated to a food distribution center in upstate New York. He said their priority is for the residents of Lake Carmel. Bob Ulich asked how to move this forward. Councilman Ruthven understood the USDA comes onsite sometime in May and do a survey and if it meets the threshold they come back in June to do the actual culling. The cost for the services is about \$2,500 plus the cost per goose.

Resolution #164 - Contract with USDA Wildlife Management Service for the Lake Carmel Park District

Resolution #165 - Authorizing Correction of Violation Acceptance of Proposal & Charge to Property Owner TM#10.-2-66.2

WHEREAS, the Code Enforcement Officer of the Town of Kent issued an Order to Remedy a Violation dated March 31, 2021 (the "Order to Remedy") directing the owner to remove rubbish at the property identified as 134 Miller Hill Road, Kent, New York, Tax Map No. 10.-2-66.2 (the "Property"); and

WHEREAS, the Order to Remedy requires the owner to correct the violations or respond to the Code Enforcement Office within ten days and, to date, the owner of the Property has not responded;

WHEREAS, pursuant to Chapter 55A of the Town Code of the Town of Kent regarding "Property Maintenance", upon the failure of any owner to comply, the Building Inspector is authorized to correct a violation subject to the approval of the Town Board; and the Town Board wishes to authorize the Building Inspector to correct the violation; and

WHEREAS, consistent with the Town's Procurement Policy, the Town of Kent requested three written proposals from contractors to correct the violation on the Property and received one proposals in response, copies of said proposals are annexed hereto and incorporated by reference; and

WHEREAS, FI Adams, Inc. submitted the lowest proposal in the amount of \$1,500.

NOW, THEREFORE, BE IT RESOLVED, the Town Board of the Town of Kent hereby accepts the proposal of FI Adams, Inc. for the correction of the violation at a cost not to exceed \$1,500; and

FURTHER RESOLVED, that the actual cost of the correction of the violation, plus the accrued legal rate of interest from the date of completion of the work, shall be charged to the property owner by the Town in accordance with Chapter 55A-12(B). Motion carried unanimously

Resolution #166 - Accepting Erosion Control Surety Bond
