TOWN OF KENT COUNTY OF PUTNAM

LOCAL LAW NO2

OPTING OUT OF ADULT USE CANNABIS RETAIL DISPENSARIES AND ON-SITE CONSUMPTION SITES

BE IT ENACTED by the Town Board of the Town of Kent, Putnam County, New York, as follows:

Section 1. Legislative Intent

It is the intent of this local law to opt out of allowing cannabis retail dispensaries and on-site cannabis consumption sites in the Town of Kent that would otherwise be allowed under Cannabis Law Article 4.

Section 2. Authority

This local law is adopted pursuant to Cannabis Law § 131 which expressly authorizes the town board to adopt a local law requesting the Cannabis Control Board to prohibit the establishment of cannabis retail dispensary licenses and/or on-site consumption licenses within the jurisdiction of the town and is subject to a permissive referendum, the procedure of which is governed by Municipal Home Rule Law § 24

Section 3. Local Opt-Out

The Town Board of the Town of Kent hereby opts out of allowing cannabis retail dispensaries and on-site cannabis consumption sites from being established and operated within the town's jurisdiction.

Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Permissive Referendum/Referendum on Petition

This local law is subject to a referendum on petition in accordance with Cannabis Law § 131 and the procedure outlined in Municipal Home Rule Law § 24.

Section 5. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.

Public Hearing Lake Carmel Park District Town Code Changes

Supervisor Fleming explained there was prior discussion on the changes that the board and the Lake Carmel Park District Advisory Board could endorse as well as residents of the district. Chairman Walter Recher thought the only significant change they have a challenge with is the one referencing that Park residents shall not attach any rope, cable or other contrivance to any tree, shrub or other plant. He said as a practical matter there are few options for residents to attach their boats to if it's not large trees which they have been doing for many years. He thinks that would be problematic but maybe an alternative like a structure or stanchion for people to attach their boats to. He said over the course of decades having a chain to a tree brought it to its end. He asked it be reconsidered. Supervisor Fleming said if you state you can attach your boat to any tree, shrub or other plant you can't say you can't do it to that little tree. She would like to keep it as is. Councilman Ruthven agrees an alternative should be considered he has seen a stanchion on DEC property in Valhalla and have some made for Lake Gleneida which haven't been put in yet specifically to save the buffer. He said this rule has been in effect for ever but has not been enforced. Walter Recher explained his experience is that well over half if not the majority of the boats are secured to something, ¾ to trees on Beach 4, Beach 6 trees or the fence. Town Counsel Tagliafiero suggested coming up with an alternative now rather than wait as there is a cost associated every time we adopt a new local law. She suggested defining the circumference of a tree or a

bush that could be incorporated or state stanchion for now even though it's not approved. She suggested taking out some of the laws and making rules that can be adopted by resolution. Councilman Ruthven said he can show you multiple trees with chains stuck in them half dead because the cables have killed the trees. It doesn't happen quickly and most times there hasn't been a boat attached in 10 years. He said he would look into the cost of the stations and inform the board. Walter thought having an option is reasonable and would be acceptable. Supervisor Fleming if that information on the stations could be received it can be brought to the LCPD Advisory Meeting next week so when this public hearing is reopened we can be on the same page. She said not just killing the existing trees but we are trying to bring the buffer back. Councilman Ruthven said that is the reason the DEP wants them out of the riparian buffer zone. He said he has researched this and can as be as simple as two big boulders with a cable in between them, there are simple options. Walter suggested a fair amount of them distributed equitably all around the lake. He did not see anyone complaining about a practical solution.
