Whereas the community solar program will benefit town residents by allowing them to save up to 10% annually on their electrical power, depending on their choice of solar energy supplier; and

Whereas this solar power is delivered by NYSEG through a voluntary opt-in program with no signup costs or cancellation fees; and

Whereas this program will create jobs for Hudson Valley workers by supporting development of solar farms in the region; and

Whereas Sustainable Putnam, a nonprofit county-wide organization, has launched a Community Campaign, "Solarize Putnam," has vetted the solar energy suppliers in this region, and has created a website with information about Community Solar with links for signing up with the supplier that was rated as superior;

Now therefore be it resolved that the Town Board of the Town of Kent expresses support for informing town residents about the NYSERDA Community Campaign, Solarize Kent, which will work in cooperation with Sustainable Putnam's Solarize Putnam campaign, via appropriate channels such as social media and websites so residents can make informed decisions about whether or not to participate in the program.

Councilman Denbaum: Wanted to object to this we had these conversations before, everyone knows his position, one of the criticism to his objections was the task force is here to do this type of stuff, to that point it is true we did pass a task force against his objections and this is something that the task force enumerated to do, to help [p the Town of Kent do some certain things whether it matter or not, he doesn't think it matters and is fine. He said a social media campaign to promote this thing fine, he will not object to this. He will just log a complaint and say that he still thinks the Climate Task Force Facebook page and social media should stick to their charter which is these type of things and not post articles of controversial bills in Congress. On how we need to pass the new Green Deal with quotes that say Republicans once called for government as the problem now they want to ruin your life. These are the articles that are being promoted by an agency of our government which is above and beyond, we do not need that in the town. This particular instance is within the scope of everything and Chris is taking a reasonable approach on this and supports it and will not object but the constant deluge of partisan postings on Facebook would end and voted yes.

Councilman Ruthven did discuss this with them after the last meeting, he said the board will look at what is posted and agree on it. There is concern that we do not take any political stand one way or another. It is about Climate Smart and the CAC's role.

Councilwoman McGlasson – thinks it beneficial to the town and votes yes.

Councilman Huestis – he hopes once this happens they do not increase it and voted yes.

Councilman Ruthven – yes

Supervisor Fleming – absolutely

Motion carried unanimously

Local Sales Tax Sharing

Supervisor Fleming said this has been discussed for years with Putnam County about sharing the sales tax amongst the towns and village. Most other counties share sales tax. She said we can't force the County to do it. She said this proposal is saying share 50% of any increase in revenue based upon the town or village population. The board discussed the pros and cons and past cooperation with the County for various projects that have worked well and the size and larger amounts of tax collected from Duchess and Westchester County. The board discussed that the proposal before them is different and maybe beginning a conversation with the Putnam County Legislatures representing Kent is a start.

<u>E – Waste Day</u>

Councilwoman McGlasson stated the County initially offered E-Waste services and has no longer been providing them. Kent hired a company but unfortunately the bins were not being filled and replaced as quickly as the company wanted. She contacted a few carters but it is a specialized service all pointing to the company SAMR. SAMR has availability this October, they provide a driver, two helpers and a box truck holding approximately \$10 - 15,000 pounds, costing \$3,250. If we need an additional container is \$2,500. The board was in agreement that this was a good idea, possibly setting the date for either October 16 or the 23^{rd} between 9:00 a.m. -12:00 noon.
