The other change is D. *any permit issued after October instead of July shall be ½ of the annual permit fee.* The third change is 39B-3 D. *Such parking spaces must be in addition to any parking spaces that are committed to other uses and/or occupancies that are served by the site as specified in the Town's zoning regulations or as set forth on any current site plan for the location is proposed to be stricken from the law. The fourth change is E. A permitted location shall not be closer than 500 feet to any existing restaurant, delicatessen, fast food establishment, or other food service establishment. To be added: <i>during the hours of operation of such existing food establishment without the express written consent of the existing food establishment.* Councilman Ruthven asked if the changes were recommended by the Health Department.
