1. New Business:

Discussion with Guest Richard Othmer about the use of salt on the roads, and alternatives to minimize the impact on the environment. The department uses a mixture of 50% salt and 50% sand. It does not have the equipment needed to apply brine solution. The solution only works if the pavement temperature is above 26 degrees F. The highway superintendent in Carmel, Mike Simone, has a mixing tank for brine. Twenty percent of salt bounces off the road. The salt can be treated with beet juice, which can result in the use of less salt and reduce the amount going into watershed. More effective plowing also reduces the need for salt. The department is using new plow blades that bend and conform more closely to the road surface. Another approach is to use a double blade. The department has replaced large trucks with smaller, less expensive 2.5-ton trucks with strong differentials. These smaller vehicles are efficient for the narrow roads in the town. A calibration procedure may be used to prevent overfilling of trucks, a common cause of excess material piling up on the roads. Mr. Othmer expressed an interest in meeting with Fred Penna, Putnam County Commissioner of highways. The KCAC will provide letter to Mr. Othmer, with cc to the Town Board, encouraging him to pursue technological options to reduce salt usage. Bill Buck will draft the letter.

- Blue-Green Algae Information Session, January 23. Bill Volckmann attended this meeting. We don't know what is causing the algae blooms, which are a tremendous problem all over the globe. Human waste from sewage and septic systems is probably the key factor. Experiments are underway to try to understand the influx of nutrients and other substances from other sources such as road run-off. Education and awareness are paramount. The Kent Lakes committee is trying to educate

the community re the importance of the septic inspection program. At the meeting, this was also discussed at county level. Remote lakes in Adirondacks, miles from roadway, also have blooms, which sometimes include toxic "cyano" components.
