## **Kent Conservation Foundation report**

- NYS DEC Volunteer Stewardship Agreement (VSA) was signed and formalized in February 2019
- The new NYS DEC VSA names The Kent Conservation Foundation (not-for-profit) as the VSA holder for the Nimham Mountain Fire Tower, which will allow the Kent Conservation Foundation to apply for grants, some of which mandate the VSA manager be a not-for-profit and not another municipal organization.

#### **Update on Hawk Rock Trail**

- Eagle Scout who created Hawk Rock Trail on NYC DEP land visited on recent break from college
- He realized that the trail cleanup re-opened the original road past the Mead farm site and he and helpers moved the Hawk Rock trail makers to the original road, rather than continue to have people blazing new paths through the forest

#### Nimham Mountain clean-up

 Each spring, before the forest leafs out, is a good time to seek litter left during the Winter months. A spring clean-up date will be scheduled for Monday, April 1, 2019 to bring volunteers together to help gather and dispose of litter along the roadway, trails and at top of the mountain.

# **Invasive plants at Putnam Veterans Memorial Park**

- Follow-up date August 19, 2019 (Monday) to check on the clean-up work performed and ensure all invasive plants have been eradicated
