Meeting Minutes

Approved minutes of the July 2020 meeting (no meeting was held in August).

**Chair's Report**

- Discussed event to honor former KCAC Chair Beth Herr.
- Webinar series topics coming up (multi-day topics) in collaboration with the NYS DEC and Hudsonia
  - Wetlands: Identification and Protection of an essential resource, September 21-24, 3:00pm to 4:30pm each day -closed
- Update on Kent Lakes Association
  - Next Lakes Association meeting scheduled for September 19, 2020
- Invasive Species

PRISM pulled about 8,000 water chestnuts from the lake at the Veteran's Park this year, compared to over 21,000 last summer. They are optimistic that they will be able to eradicate the water chestnuts completely in future years. Dorian D'Ausilio, member of the Lake Tibet Park District No. 2 Advisory Committee had been informed by Bill Buck that having firetrucks pump water in and out of the lakes may spread water chestnuts.

However, the DEC does not seem to have issued a strong recommendation to fire departments to reduce spread of any invasive that is water-borne. The use of "draft hydrants" and the transfer of water via their trucks from one body of water to another may cause spread. Chris has spoken to Ken Clair of Putnam County, who oversees the Fire Training Center, about this issue. This has also been discussed by the Kent Lakes Association, and Town Supervisor Maureen Fleming has discussed it with Bill Walters of the Lake Carmel Fire Department. Bill V. has approached this issue with the DEC. Directives originating from the state level may be needed to address this issue.

KCAC members are encouraged to get involved in the Arts on the Lake photography contest.

## **KCAC Projects**

### **Climate Smart Communities (CSC)**

Agreed upon changes to the Kent KCAC Info and Kent Conservation Foundation websites. Jasper Katzban will be hired to develop and host the Kent Climate Smart website. Anne will forward the latest draft of the “How green is my town” survey to Chris, who will attempt to obtain answers to the outstanding questions. Anne also will look into obtaining the calculation tool used by Ulster Climate Smart for their greenhouse gas inventory.

### **Kent Natural Resources Inventory (NRI)**

- A proposal for funding the development of an NRI by Hudsonia has been submitted to the Putnam County Soil and Water District.
- The Kent Biodiversity Inventory project is getting increasing support from different lake associations, which have been welcoming the volunteer naturalists and even providing volunteers to assist them in the field. Chris Ruthven suggested contacting the Kent Lakes Association and perhaps giving a presentation at one of their meetings. The team has made arrangements with the Natural History Museum at the University of Connecticut to accept insects for their collection.
- Bill V. will remind Nate Nardi-Cyrus of DEC that we are waiting to receive their Biodiversity data of known species to assist with our inventory.

### **Other CAC projects**

- Highlands Trail / North Putnam Greenway trail project with NYNJ Trail Conference – no new activity

### **Development Projects in Town of Kent**

- No updates on new development projects in the town
- The Town Board wants to start the update of the comprehensive plan and also work on a mining ordinance.
