## **Kent Natural Resources Inventory (NRI)**

Seeking funding to cover the cost of the NRI through the Hudson River Estuary Program grants program <a href="https://www.dec.ny.gov/lands/5091.html">https://www.dec.ny.gov/lands/5091.html</a>. Soil and Water district funds could be used to augment any funding obtained via DEC. Discussed request for an updated quotation from Hudsonia for NRI work.

Diversity data of known species forthcoming from NYS DEC to assist with survey – delayed because DEC is tasked with other activities now. Nate Nardi-Cyrus is working on this. Anne and Bill B. to follow up with Caleb Duncan re letters of support for the proposal

Update on Kent Biodiversity Inventory project: Fieldwork is ongoing.

NYS Parks and Trails Association grant was announced just three weeks before the deadline and KCAC was unable to apply on such short notice this year.

## Other CAC projects

Discussed proposed changes to the town code to accommodate soil removal, excavation, and mining in connection with proposed land development projects in the Town of Kent and the response to the town board from the CAC and Planning Board. The Town might be able to obtain funding via the NYS Hudson River Valley Greenway – Community Grants Program to help cover costs of revising the Town's soil removal code to address excavation and mining. Chris Ruthven will try to get cost estimates to Caleb in time for the May 7 deadline for the application.

Highlands Trail / North Putnam Greenway trail project with NYNJ Trail Conference: Gary Haughland and Matt Paul regional forester for DEC hiked Big Buck Mtn. and White Pond and the new parcels that connect them and reviewed the theoretical trail path that they had been working on. Gary Haughland is making proposals to DEP on use of their land for this trail.

#### Town of Kent CAC hikes and events

Bill V. talked with Jared and will speak with him further about the registration process to support social distancing for COID19. Hawk Rock hike tentatively set for May 23 at 11 AM. Looking for another volunteer to help lead.

#### Planning for new events

Astronomy night: postponed due to COVID19 – perhaps could be hosted this summer or early fall. We have reached out to Westchester Astronomers Club as co-hosts – Bill V. will set up some new dates with them in June or September.

Mushroom walk: we will ask COMA to suggest a location. Bill V. will email Lou Tartaro about this.
