Overview of 2016 Preliminary Budget

Taxes

There are no tax increases in the 2016 Preliminary Budget.

In the special districts, there is a 2.96% increase in the Lake Carmel Fire Protection District and a 2.57% increase in Kent Fire District #2. All other existing districts remained the same.

Town Retirement Contributions

In 2016, New York State Retirement contribution decreased for the second year in a row.

The NYS Retirement contribution decrease has had a positive effect on the 2016 Preliminary Budget.

Health Insurance Contributions

For health insurance, the Town estimated a NYSHIP increase of 8% in the 2016 Preliminary Budget.

Salary Increases

The 2016 Preliminary Budget has modest salary increases in the personnel contractual lines based upon pending contract negotiations. There are no planned increases for elected officials.

General Fund

General Fund Revenue

No tax increases in the 2016 Preliminary Budget.

General Fund Expenses

All general fund department heads were asked to review and cut budgets resulting in savings in equipment and contractual expenses. For benefits expenses, there were significant savings from retirement contribution expenses to offset health insurance increases.

General Fund Balance

In the 2014 Budget, the Town approved using \$444,000 of the fund balance and raised taxes by 1.66%. In an effort to decrease reliance on the Fund Balance to balance the budget, the Town reduced expenses without impacting services to the residents. In 2014, cost cutting measures resulted in an increase in fund balance of \$422,000 rather than a budgeted use of \$444,000. For 2015, the budget reflected the reduced expenditures and the Town anticipates staying within budget. In the 2016 Preliminary Budget, the Town of Kent succeeded in its efforts to reduce reliance on the fund balance and not raising taxes in the General Fund Budget. In the 2016 Preliminary Budget, the Town approved the Recreation Department's request for a replacement truck and plow for an additional capital expenditure of \$60,000 out of the fund balance.

Equipment

\$545,000 of fund balance in the 2015 Preliminary Budget is being used to offset increases in the equipment budget. In 2015, the equipment budget was \$237,500 versus \$520,000 in 2016. The Town will pay for the equipment outright rather than bond it.
