



Condensing Unit: The condensing unit will be Carrier Comfort air conditioning and it will be 36,000 btus @ 14 SEER.. It will be installed outside in an agreed upon location and it will sit on a pre-formed 2" pad. It will have a separate weather tight service disconnect and conduit.

<u>Air Handler:</u> The air handler will be Carrier Comfort series and it will be located in the attic and it will sit on a Goliath base. The base will serve as the secondary drain and it will be equipped with an integral float switch to help prevent water damage to the ceiling if the primary drain system fails. The condensate piping will be PVC plastic and it will connect the nearest plumbing drain.
