Surety bond for \$13,000

The project proposes construction of a single family house with well and septic. The parcel received variances from the ZBA in 2006. Information provided indicates the lot has Putnam County Health Department approval for well and septic. The project was previously granted an Erosion Control Permit in 2006, which has since expired. A cash bond of \$9,235 was provided in 2006, which the Town still holds.

In 2016, a new application was provided and after the review process, it was granted conditional approval in December 2016, with a revised bond amount of \$12,650.00. Since then, the project has been working through final approval conditions.

In 2017, the Town Board adopted Local Law No. 3 "Local Law authorizing the acceptance by Town of Kent Boards of surety bonds and letters of credit in addition to cash bonds."

The project applicant provided a \$13,000 surety bond and requested the release of the original \$9,235 cash bond. The Town Board's attorney indicated that the local law does not allow for a new surety bond to be substituted for an existing cash bond.

The applicant is currently requesting the \$13,000 surety bond be used to fulfill the requirement of the additional \$3,415 bond. The Town will then hold the \$9,235 cash bond plus the \$13,000 surety bond.

We have no objection to this arrangement. We recommend the Planning Board recommend to the Town Board to accept the \$13,000 surety bond in addition to the existing \$9,235 cash bond to fulfill the requirement of the erosion control bond for this project.


