- Highlands Trail / North Putnam Greenway trail project with NYNJ Trail Conference
- Trail on NYC DEP Horsepound Brook unit
 - NYC DEP is seeking public use ownership/stewardship for a trail that has been an unofficial trail for many years and was recently blazed by a private land owner nearby for their private use
 - NYC DEP will only approve public use of a trail on their land
 - Town of Kent CAC has an existing land and trail stewardship agreement in place with the NYC DEP for the Horsepound Brook unit for our Tom Morgan/Hawk Rock trail. The CAC has sent a letter to the DEP requesting we add this additional section of trail in the same DEP managed unit to our stewardship agreement.
 - The CAC will plan to improve the trail to make it ready for addition to the Highlands Trail which is in planning
