She said Putnam County has a long history of honoring Veterans back to 1919 when a commemoration parade celebration was held for returning WWI Service members and special designed service medals were awarded. The Legislature has just established a Veterans Service Medal Advisory panel which she is proud to be a part in deciding the look. She thanked Joseph Stillwell for his generous donation of \$40,000 to the Putnam County Sheriff's Department to purchase a canine vehicle. She wished everyone a Merry Christmas, Happy Hanukah and Happy Holidays. Supervisor Fleming thought it great to apprise the residents.
