WHEREAS, by Memorandum to the Planning Board dated January 8, 2015, the Town's Planning Consultant has recommended that \$65,380 of the Bond be released, and \$2,000 of

the Bond be held until certain stabilization issues are addressed by the Owner and a Notice of Intent is filed with the NYSDEC; and

WHEREAS the Planning Board, at their meeting held on January 15, 2015 approved Resolution #1 of Year 2015, following the Town Planning Consultant's recommendation that \$65,380 of the Bond be released, and \$2,000 of the Bond be held until certain stabilization issues are addressed by the Owner and a Notice of Intent is filed with the NYSDEC; and

WHEREAS, the Town Board of the Town of Kent wishes to follow the recommendation of the Planning Board;

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Kent hereby authorizes the release of \$65,380 of the Bond, and the retention of \$2,000 of the Bond until the outstanding stabilization issues have been addressed to the satisfaction of the Town Board, and confirmation is received that a Notice of Intent has been filed with the NYSDEC. WHEREAS, the Code Enforcement Officer of the Town of Kent issued an Order to Remedy a Violation dated December 16, 2014 (the "Order to Remedy") directing the owner to remove all building materials, insulation, wood, plastic and metal debris from the exterior area of the property identified as 24 Chauncey Road, Tax Map 33.56-1-20 (the "Property"); and

WHEREAS, the Order to Remedy required the owner of the Property to remove all building materials, insulation, wood, plastic and metal debris from the exterior area of the Property or submit a written request to the Code Enforcement Officer for a hearing to discuss remedial action to abate said violation within ten days; and

WHEREAS, to date, the owner of the Property has not corrected the violation as required by the Order to Remedy, nor submitted the required written request to the Code Enforcement Officer to discuss remedial action to abate the violation; and

WHEREAS, pursuant to Chapter 55A of the Town Code of the Town of Kent regarding "Property Maintenance", upon the failure, neglect or refusal of any owner to comply, the Building Inspector is authorized to correct a violation or cause such violation to be corrected subject to the approval of the Town Board; and

WHEREAS, the Town Board wishes to authorize the Building Inspector to correct the violation and the costs of such correction will be charged to the property owner; and

WHEREAS, consistent with the Town's Procurement Policy, the Town Board of the Town of Kent obtained written proposals from contractors to correct the violation on the Property; and

WHEREAS, Dirt & Demolition Guys of New York LLC has submitted the lowest responsible proposal; and

WHEREAS, the Town Board of the Town of Kent wishes to accept the proposal submitted by Dirt & Demolition Guys of New York LLC in the amount of \$1,309;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby accepts the bid of Dirt & Demolition Guys of New York LLC for the correction of the violation on the Property; and
