Public Comment

Mr. Scalfani an owner of property in the Sewer District had concerns about his billing in the Sewer District, he is being billed for 5 units, 5 toilets, sinks and tubs, he has no building on the property, he visited the Assessor and his assessment has remained the same. He is paying \$4,200 a year for a system he is not in. He said the town cannot deliver it is a theft of service. Councilman Denbaum explained the allocation of flow to everyone within the district. He said the only way to get out of the Sewer District is to get an exemption, the exemption will be taken up at the May 11 Sewer District Committee meeting and will give an advisory opinion to the Town Board. He said the concern is the purpose of the district is to allow Commercial development, the fact you have vacant land not improved may or may not be a reason to exclude you, if you get excluded you have no flow, no ability to hook back into the district, that land potentially can never be brought back in . The fact that you have commercial land that may or may not be improved yet may not be a reason to exclude you. If you get excluded you'll have no flow, no ability to hook up back into the district, that land can potentially never be brought back in. You would have 5 parcels completely unbuildable, worthless and have no value. There are concerns letting someone out within the district. He is preparing him for the reality of the situation. Councilman Tierney asked about the foundation. Mr. Sclafani replied everything was removed. He said he can never be denied the sewer district, as soon as you took money from DEC, DEP there is a connection, he is in the system whether you like it or not, when he hooks up is when he gets billed, you cannot charge him a rate, it has nothing to do with a flow in or out. He has a lateral going to the property; he cannot pay for something on a play of words. Councilman Denbaum explained flow; he said the only way he cannot be charged is by taking away his flow. Mr. Sclafani said he has been allocated, he said do not think that you will be the only treatment plant, he said not to worry about the flow it will be there. Supervisor Fleming thought his situation is unusual, the vacant properties were not supplied a lateral, since the other property is not on line and not a problem with the flow maybe an accommodation could be made to diminish the bill, obviously you were supplied with a benefit other vacant commercial properties were not; the board has not dismissed your application rather has not come to a conclusion. Mr. Sclafani would like the \$4,200 back; he has an appointment with an attorney. Councilman Denbaum explained this came up at the sewer district meeting and these were concerns, he doesn't know why Insite gave your vacant property an allocation opposed to other vacant properties.
