### Public Hearing - Business Tax Exemption Law

Supervisor Fleming read the notice of hearing to those present. She asked for public comment there was none. Councilman Denbaum explained under the Business Tax Exemption Law any new commercial construction business type enterprises that are improved on or built will receive a 50% exemption on their town taxes for the first year, 45% the second year and then decreases over the period of ten years. If you build a commercial building in the Town of Kent and get an assessment based on its value you only pay half of those taxes, and less taxes going forward for ten years. If you invest in Kent you will do so at a discount. Hopefully as the Sewer District comes further along and vacant lots are built upon business will take advantage of this bringing more business and development to our commercial sector. Councilwoman Osborn said it came to her attention some business's like the cleaners in Lake Carmel and the print shop made improvements, she asked if they would be eligible. Councilman Denbaum said the State Law which we are mimicking as long as you have improved the property since 1992 and can show the improvement raised your assessment a specific amount you are allowed an exemption on that improvement. He said when the Kent Cleaners gets a building permit they will get a new assessment and they would be able to apply for the business exemption based upon that assessment increase. He does not believe the print shop would be able to because there is no increase in assessment. He believes since they have been there since 2008 there is no correlation between the increase in taxes and the investment. He said the law is in place in a scaled back version which they could of applied for, which they didn't. Supervisor Fleming reported that Bill Nulk, of the Chamber of Commerce stated they were fully behind the passage of this. Supervisor Fleming asked the hearing remain open to allow for comment and people to weigh in on this, and asked comments to be received by the 17th of July.

#### **CAC Butterfly Count Presentation**

Beth Herr, Chairperson of the CAC explained since 1976 under the Town Code, the CAC has been in charged with having public programs and an inventory of natural resources within our town. The Butterfly Count accomplishes both goals. Butterflies are beautiful and are the canaries of the environment they have two life cycles, caterpillar and butterfly, they have different stresses on both cycles and can be an indicator of an eco system's health. She said it's so important that there is a National and North American Butterfly Association that holds counts around the weekend of July 4<sup>th</sup> which they will team with. The butterflies they find will be entered into that data base, becoming a larger citizen science project. We will learn how the monarch butterfly numbers are doing, how are butterflies responding to climate change and what are the different stresses that might impact that. By attending the event you will learn about the life cycle of the butterfly, the difference between moths and butterflies, and the 100 different species. We will look for eggs and caterpillars. They will be meeting at the Nimham Multiple use area at 10:00a.m. on July 18<sup>th</sup>, and caravanning to other meadow sites.
