Supervisor Fleming – votes yes because this is a non-developed parcel at this point, we do not have undeveloped parcels being charged. Mr. Sclafani was provided a connection and is willing to pay a portion even though he doesn't have flow, she doesn't think it unreasonable to reduce the flow.

Councilman Denbaum – nay, he understands the property seeking to be exempt is currently without plumbing and is a garage, but that is the case on many properties in this district, Mr. Sclafani's included and other properties that are allocated flow and not hooked up, there are a lot of properties not hooked up to a toilet right now. The intent is if you do not have a toilet or plumbing you are exempt out from the sewer district. This individual does not plan to improve the garage at this point and put plumbing in it that is not unlike many members of the Sewer District. With

the intention to not improve it right now is not enough of a reason to exempt it from the sewer district and voted nay.

Councilwoman Osborn — aye, it is on a very small parcel, they are never going to be able to develop it, and if they were to develop it they would need building permits. Not being hooked up to the sewer would not probably work in their best interest, it would not be able to be developed anyway, under those circumstances, you cannot compare this piece of property to Mr. Sclafani' who has a large parcel which can have a vast development on it, this one is just a garage and should not be in the district and voted aye.

WHEREAS, the Order to Remedy was provided to the owner of the property located at 33 Ticonderoga Road on July 29, 2015 and ten days will have elapsed on August 8, 2015; an

WHEREAS, pursuant to Chapter 55A of the Town Code of the Town of Kent regarding "Property Maintenance", upon the failure, neglect or refusal of any owner to comply, the Building Inspector is authorized to correct a violation or cause such violation to be corrected subject to the approval of the Town Board; and

WHEREAS, the Town Board wishes to authorize the Building Inspector to immediately correct the violations at 35 Lockwood Road, 34 Larchmont Road, 56 Vernon Drive and 28 Fairfield Road and the costs of such correction shall be charged to the property owners;

WHEREAS, the Town Board wishes to authorize the Building Inspector to correct the violation and the costs of such correction shall be charged to the property owner of 33 Ticonderoga Road, if the violation is not corrected or a written request to the Code Enforcement Officer for a hearing is not received by August 8, 2015, and

WHEREAS, consistent with the Town's Procurement Policy, the Town of Kent obtained written proposals from contractors to correct the violation on the Properties, copies of which are annexed hereto and incorporated by reference; and
