#### **Public Comment**

Kathy Kahn from the Hill & Dale Property Owners read a letter submitted to the Town Board (attached). Mr. Addonizio brought to the attention of the board, that one of the individuals from the concrete plant has jumped the fence onto his neighbor's property and approached them, it was not a good situation. He added the police were notified. Mr. Veteri explained he was the neighbor, they started a confrontation with him on his property. He asked what the Town is going to do about this. He has complained numerous times, it looks like Yankee Stadium. He said last Saturday the Building Inspector drove on Miniello at 7:30 and was surprised to see them working. He is now afraid on his own property. He said they do whatever they want as the fines are a joke. The mulch company is running their equipment whenever they want. He asked if the Town is going to do anything. At the last meeting he brought to the attention of the board the vouchers. He said someone is lying. Town Attorney asked if the vouchers were submitted with their court proceeding, she explained he is saying that the vouchers show that the decision was drafted before the last public hearing. Councilman Denbaum was aware and brought it up to the board. Town Attorney thought it important to be part of his proceeding to the court. The court is going to make a determination about the Zoning Board's actions. Mr. Veteri thought the Town can make determinations of their own actions too. Councilman Denbaum said we have a law supporting the Board of Ethics, we could make appointments and determine if there was inappropriate contacts. Town Attorney asked the recourse they are no longer on the board. Councilman Denbaum thinks the town board should investigate the lighting issue, the code enforcement officer and building inspector should determine if it is a violation of the nuisance laws, it should be done quickly. Mr. Veteri asked the fines be looked into. Supervisor Fleming thought that should be looked into.
