### 2016 Preliminary Budget Public Hearing

Supervisor Fleming announced this is a continuation of the 2016 Budget Hearing opened on the 5th of November. She has received one comment (attached) asking the board to support the funding level of the Kent Library as presented, which was not changed. Councilman Huestis asked if Rich Williams and the Advisory Board can be contacted about Lake Carmel's requests for purchases of a truck, backhoe, dock, etc. He understands the funding is available for Porta Johns at the two Historical Museum Sites. He said the conditions at Huestis Park are deplorable some improvements have been made; pot holes have been filled, the gate has been painted. The basketball court needs help the paving of the entrance way, people stay away when it looks like this. He would like to get permission to approach DEP for a land swap opening the adjacent parcel to recreation. He agreed with Councilman Tierney's suggestion for a Town Hall Floater to assist in the needs at Town Hall, not conflicting with the Recreation Clerk so that the Director can progress. He said in regards to Old Town Hall, he suggested an appraisal be done to establish value for possible sale or possibly worth Supervisor Fleming thought the equipment purchases for Lake Carmel were resolved. keeping. Councilman Huestis replied he was not present at the session; he leaves it up to the liaisons, maybe a phone call. Supervisor Fleming was perplexed as the concerns were not mentioned when the board met with the recreation department; she asked if an amount is being proposed to add to the budget. Councilman Huestis replied at this point he is bringing it to her attention and will be back at the table. He is trying to get funding for various other projects particularly the one room schoolhouse and the museum on Route 52. Supervisor Fleming asked for comments there were none.

#### Workshop

The board reviewed and discussed the items on the workshop agenda.

#### Public Comment

Bill Walters, resident of Kent for 57 years, questioned why we hire a contractor to pick up garbage at Town Hall, the Police Station and the Library when we have our own garbage truck. He heard this was done when the Lake Carmel Fire Department was built it is just outside the Sanitation District, and if the Town Center wanted pick up we would have to pay Lake Carmel Sanitation. It doesn't make sense when our trucks drive right by to hire an outsider and asked why. Councilman Denbaum thought maybe because of the dumpster. Bill Walters said when the Fire Department was located at the Arts Center their garbage was picked up by Lake Carmel Sanitation and a dumpster was provided. Councilman Tierney recalled residents off of Barrett Hill requesting the Sanitation District be expanded. Bill Walters is not suggesting the district be expanded, he does not understand why we are paying tax payer dollars to contract with a hauler when the district stops 200' from the door, it doesn't make sense to him. He said we talk about change, maybe something should change. Councilman Denbaum said we will pay the new contractor \$3,000 a year to pick up the garbage, with the addition of the dumpsters and the fees for carting, if it is just over the edge of what we are capable of it will cost more than \$3,000. Councilman Huestis see's the Lake Carmel Park District rich in facilities, the Art Center is beautiful, yet the Community Center needs help. Sanitation is another thing, people pay additional taxes for it, and there have been other issues. He's being told in past negotiations, that the members of the LC Fire Department never brought up the issue of sanitation at the new fire house. Bill Walters replied not that he is aware of, but he has not been part of those negotiations. Councilman Huestis said we have to look at how we can save money, cut costs, and improve services to the taxpayers.
