WHEREAS, pursuant to Chapter 61 of the Town Code, §61-86 (B), all properties in the Kent Sewer District are required to meter water usage, and the actual average flow will be calculated as the metered flow of the prior year; and

WHEREAS, §61-86(B) provides that it is the responsibility of each property owner to provide and file with the Town Clerk an Affidavit of Actual Flow by July 15 of each year, or at the option of the Town, the flows specified in the Town Code shall be utilized to calculate the sewer charges for the next year; and

WHEREAS, in 2015, the Town Board extended the date to file Affidavits of Actual Flow to September 1, 2015;

WHEREAS, in accordance with §61-86(B) of the Town Code, one unit for assessment purposes equals 223 gallons per day ("gpd"); and

WHEREAS, pursuant to §61-87(C), the lowest unit level per assessment is 100 gpd; and

WHEREAS, by Affidavit of Actual Use it has been established that the property at 474 Route 52 had an actual flow of 1660 gallons over 38 days, which equals a flow of 426.84 gpd, and as one unit for assessment purposes equals 233 gpd, 426 gpd divided by 223 equals an assessment of 1.91 units; and

WHEREAS, by Affidavit of Actual Use it has been established that the property at 38 Chauncey Road had an actual flow of 3190 gallons over 61 days, which equals a flow of 52.29 gpd which is below the minimum of 100 gpd, and as one unit for assessment purposes equals 233 gpd, 100 gpd divided by 223 equals an assessment of .45 units; and

WHEREAS, by Affidavit of Actual Use it has been established that the property at 507 Route 52 had an actual flow of 324 gallons over 39 days, which equals a flow of 8.31 gpd, which is below the minimum of 100 gpd, and as one unit for assessment purposes equals 233 gallons per day, 100 gpd divided by 223 equals an assessment of .45 units; and

NOW THEREFORE, the Town Board of the Town of Kent hereby directs and authorizes the Town Assessor to revise the 2016 Assessment Roll as follows:

474 Route 52: 1.91 units; 38 Chauncey Rd: .45 units; and 501-507 Route 52: .45 units. Motion carried unanimously
