WHEREAS, Section 103(16) of the General Municipal Law exempts from competitive bidding purchase contracts for apparatus, materials, equipment and supplies, through the use of contracts let by the United States or any agency thereof, any state or any other political subdivision or district

WHEREAS, the Town Board has determined that there is a need to purchase the Truck; and wishes to authorize the LCPD's purchase of the 2017 Chevrolet Crew Cab for a price not to exceed \$41,214 through a contract awarded by the County of Rockland to Robert Green Truck Division pursuant to Contract #RC-2014-087; and

WHEREAS, according to Mr. Mancuso, Chevrolet no longer constructs its trucks with the necessary equipment for dump assembly required by the LCPD, and, as such, a bid for the fabrication and installation of a dump bed has been obtained from Burquip in the total amount of \$4,665; and

WHEREAS, according to Mr. Mancuso, Burquip is the only company that is able to fabricate and install the necessary dump bed;
