<u>Pledge of Allegiance</u>- At 7:10 p.m. Supervisor Fleming called the Workshop Meeting to order with the Salute to the Flag.

Stormwater Presentation

Bruce Barber the Towns' Wetland and Stormwater Consultant presented the Annual MS4 report to comply with the Towns NYS DEC permit. He explained stormwater is simply run off from rain, snow melt, ice and things of that nature. Through Federal studies it was determined that stormwater runoff is a substantial origin of certain types of pollutants. What is in that runoff in developed areas are sand, litter, oil, antifreeze, pollutants from fertilizer, animal waste and a variety of different chemicals that have been spilled or absorbed. The EPA decided to regulate it and passed the regulatory to the States. The New York State Department of Environmental Conservation is in charge of Stormwater Compliance. The majority of the Town of Kent is within the Watershed of New York City which entails additional compliance requirements having to do with phosphorus reduction. In order to comply with the permit the town has to show compliance with six different components. He explained the report is the compilation of the hard work of the town staff, the Highway Department, the Planning and Building Department, the Recreation Department, the Supervisor's and Councilman and the Town Clerk's office. He explained Minimum Measure 1. Has to do with Public Education and Outreach. To meet that they have trained 11 construction site operators, they have displays and kiosks, different events and presentations, 366 brochures were printed and distributed at Town Hall and the Library. Minimum Measure 2. Public Involvement/Participation, the Town has a Cleanup Event every year; there are meetings at the consultant level as well the Planning Board, Town Board and stakeholders as well. Forty people attended community meetings and 144 attended stakeholder meetings. The Town's website provides a rich resource 24/7 on the various stormwater programs. Minimum Measure 3. Illicit Discharge Detection and Elimination are those components coming into a stormwater conveyance system like a stream or drainage. Typically they see, washing machine water, some septic systems which must be corrected. They are all inspected, this year they found 3 illicit discharges. Minimum Control 4 & 5, Construction Control. During construction when the land is dug up there is runoff. That runoff itself is a pollutant and can also carry with it additional pollutants. They review every single project to determine if there will be land disturbance, if it is greater than 5,000 sq. ft a stormwater plan is required. Sixteen stormwater plans were reviewed and accepted, there were 6 notice of violations and 2 stop work orders. They also inspect the sites to assure the erosion controls are installed properly, Stormwater structures are inspected and maintained. Minimum Control 6 Housekeeping is how we maintain municipal operations. The Highway Department swept 5 acres of parking lots, 215 miles of road, inspected 440 catch basins; we do not use phosphorus fertilizer or pesticides. We conducted training throughout the year for staff and contractors. We are in compliance with the heighten compliances through the East of Hudson Corporation involved with installing stormwater basins seen throughout the town. They are done with DEP funding, the way it is presently structured the maintenance will be the responsibility of the Town. He said the Highway Department was completely cleaned up, bins and a salt dome were constructed to contain material, and areas were swept and expanded. Work was done with East of Hudson assuring phosphorus reduction in the more highly developed areas within the town. He is looking forward to additional stormwater improvements through the next five years. He said the Town Board has begun developing a stormwater committee which will be an asset in many ways and the formation of a Lakes Committee which will be very positive to reverse some of the conditions in the lakes. The Town is in full compliance. He asked for questions or comments there were none.

<u>Workshop</u> – The board discussed all the items on the workshop agenda.

Public Comment

Sue Kotzur from Nimham Road spoke for all that live on the road about the wonderful work the Kent Highway Department did. She thanked Rich Othmer, the Highway Staff and those hired for the fantastic job.

A resident of 24 Chauncey Road said he has a problem; he has been trying to sell his home but has a violation. He asked for help he is behind in his mortgage, he has someone who wants to buy his home, but is in court and time is running out. Councilman Denbaum said the board cannot remove the violations, he said he has to clear up the violations; the Building Inspector cannot issue you a permit until the violations are cleared. Town Counsel Tagliafierro suggested the buyer work with him to clear the violations to purchase the home. Councilman

Denbaum instructed that he can complete the application for a permit, but because of the violations it will be denied, at that point you will make an application to the Zoning Board of Appeals to appeal the denial of the permit, you may have some compelling reason.
