#### **CAC Presentation**

Beth Herr, Chair of the Kent Conservation Advisory Committee thanked the board for the opportunity to update all on their activities. In the fall they had foliage walk to the fire tower, a New Year's Day hike and a nature walk on Town property. They sponsored a wood cox walk and had a slide presentation on Kent and the beautiful parks surrounding town. A wildflower walk and the popular hike to Hawk Rock. In addition to the public programs they sponsored a photo competition, which were displayed at the library and currently on display at Town Hall. An upcoming event will be a Star Party, on the lawn of the Town Centre either in August or September. They have also been working with an Eagle Scout who designed and completed a project to Hawk Rock, there now is a kiosk, map, and the trail is blazed and easy to follow. Currently they are working with another Eagle Scout who will be making a boardwalk over wetlands. Both projects were in conjunction with NYCDEP, she explained the CAC maintain a stewardship with them to keep the trails open and safe. The CAC sits on several committee's one being the Clearpool model forest, which is advantageous filling in our natural resource inventory. They attended the annual NYS Conference with other towns that have CAC's. They also attended a workshop on creating a natural resource inventory to prepare for future grant writing and a seminar on water quality assessment where citizen scientist do protocol tests on local streams, which they did a few. They hope to have a program including the general public. The CAC toured the new forestry project at Lake Tibet; it is great and should be interesting as it proceeds. They sit on the Environmental Leaders Learning Alliance, a group of EMC or CAC throughout Westchester, Rockland, Putnam and Dutchess County a great resource. They maintain agreements with DEP and with DEC. They have been very busy maintaining the Fire Tower with various projects, including painting, cleaning, and an engineer's report on the future maintenance of the tower. They continue to reach the public through their Face book page and the Kent Nature Almanac.

David Ehnebuske spoke about an adjunct of the CAC a not for profit called the Kent Conservation Foundation, KCF a 501 (c) (3) to maintain the fire tower. He said the labor has been volunteer, but it does require materials and the hiring of an engineer. The objective is to let the CAC identify a conservation orientated project that needs to get done but otherwise could not be funded. The Kent Conservation Foundation is there to supply the additional funds. If interested in joining or donating he provided a brochure which will be also be available at the Town Hall and the library.

<u>Workshop-</u> The board reviewed and discussed all the items on the workshop agenda.

Pat Madigan Co-Chair of the Lake Carmel Park District Advisory Committee presented to the board a letter with the committee's concern's in regards to the TMDL report for Lake Carmel. (see attached) Supervisor Fleming replied before this draft was put out, representatives were present from NYSDEC, she thinks after the report is finalized she will ask them to do another public hearing. In regards to the Blue-Green Algae she said she is scheduling a meeting with Lakesavers for alternative solutions. In regards to the other towns in the watershed, the town of Kent is part of the East of Hudson Corporation and they are looking at practices to be implemented around the lake. Pat asked if the board will be responding or commenting by the July 1<sup>st</sup> date. Supervisor Fleming replied she will be corresponding with Bruce Barber before the 1<sup>st</sup>. Pat said she was surprised when the committee was not asked to be present when the meeting took place with Insite and asked for minutes. Councilman Denbaum took notes that he will provide.
