This program entitles you to purchase discount lift tickets, discount lessons and rentals.

Program will take place on **Saturday Evenings**

Program Dates: January 6, 13, 20, 30, February 3 and 10.

Program Time: 5:00pm to 9:00pm

Lesson Time: 5:30pm

Single Person Registration Fee: \$8.00 **Family Registration Fee:** \$20.00

Discount Lift Ticket Fee: \$16.00 per night (paid each Saturday night at Thunder Ridge)

This is for those who sign up for the program but not ski or snowboard lessons.

Nightly Equipment Ski or Snowboard Rental Fee: \$25.00

Ski or Snowboard Lesson Fees: \$126.00 for six 1 ½ hour group lessons

Children must be in 1st grade in order to participate in ski lessons and snowboard lessons.

6 Week Lesson and Lift Ticket Fee: \$222.00* **6 Week Lesson, Lift Ticket and Equipment Rental Fee:** \$372.00

*If you are taking lessons and do not have a Thunder Ridge Season pass you must pay for your lift ticket and lessons together.
