Notes to the Board

- Last year, 2019 was the first year all of us had ever bonded money together and it was a very new experience to myself. I solicited advice from town attorneys, highway superintendents and town board members from Kent & other municipalities as well. I spoke with the Attorney General's office in Albany to ensure proper procedure was observed. There was much misinformation & hearsay floating around that needed to be sorted out. It can be unnerving to have the freedom to spend 1.5 million dollars of the people's money on your word alone. I have a good handle on it now & we are making great progress in rebuilding the infrastructure of Kent.

- Being a new experience, I did not have an established system in place in order to monitor progress in relation to monies spent. I therefore submitted a mid-year & year-end bonding progress reports.
- I want to establish a protocol tradition of submitting the current year's bond construction progress report to the Board during the budget process coinciding with the end of the 3rd fiscal quarter. By mid to late August 90% of the current bond road work should be done already. This will enable Board members to make a more informed & educated decision on how to budget for the following year by accessing the immediate years progress.

Street Signs

1) In 2009 the Federal Government mandated that all street name signs be increased from the standard 6" to the new 9" reflective signs.

2) This was instituted because of the aging population of "Baby Boomers" which will comprise almost 40% of the US population in 2025. The sight distance & new reflection technology was needed, especially for night time driving.

3) When I took office on January 1, 2014, not a single new 9" sign had been installed in Kent. If a serious accident had occurred because of a lack this responsibility & a continuing program was not verifiably in place, the Town was liable for damages.

3) I have installed these signs in the federally approved "Blue" color. Kent is surrounded by nine other towns & one county. It clearly distinguishes when a motorist is travelling on a Kent roadway.

4) There are approximately 2,000 street signs in Kent at an average cost of \$100.00 = \$200,000.00

5) The old historic white & black "Kent Town Line" signs are being installed at all town borders.
