They never took them out so the fee schedule which is the same as the County and when they called around to see what other towns were getting they stayed with the same fee schedule for the gas inspection which is currently what the County is doing which is \$50.00 for residential, \$100.00 for commercial, in ground tanks is \$100.00, re-inspection \$75.00. They have been doing a lot of re-inspection because there's been problems. Councilman Denbaum asked if there's no change with from the County's fee schedule. Fire Inspector confirmed affirmatively.
