He hopes next year we have a long process that we can receive more than one bid, it doesn't mean we have to change, or the product, he thinks it's a problem buying the same product year after year without another option. Councilwoman Osborn — aye- She feels an extension was given. The date was established to

open on that date at noon, we waited until 1:25 p.m. in the event someone wanted to submit a bid. We gave as much as we possibly could. Although it was one bid there was a considerable savings with NYMIR, the price came down quite a bid. She thinks going out for the RFP was a good idea, the town is in a good position with NYMIR.

Councilman Huestis –He said the process for next year has begun. There are a variety of other things to improve themselves, we will be working hard to get other options, he voted – aye. They will improve things involving safety and others to improve the Town of Kent.

Councilman Tierney – He thanked his fellow board members, they campaigned on this issue and came through, credit is due to the new members of the board. He appreciates their efforts sincerely and voted aye.

Supervisor Fleming – She said the process was truncated, by the time we sought other proposals we were running against a deadline as the insurance term runs from April 8, to April 7. One of the brokers interested in bidding who did not actually submit a bid has been in touch with her and said even though their company is not insuring the town she would be happy to work with the Town to give answers to questions, to sit down with them and work towards improving our insurance in ways that might need improvement to which she is grateful. When you open the process and discussion up you do get the best results, but as we only have one bid, the process did work, the Town did save in the premium at least \$44,600 over last years premium, going with the same agency. If we bid this out next year we are going to start earlier to speak to as many people as possible and have a situation where people have a sufficient amount of time to come forward, with that being said she voted aye.
