She said the purpose of the amendment is to provide the town with enforcement powers in all the wetlands within the town regardless of the designation or size, this has become an issue in that there were certain areas excluded from our enforcement capabilities. Violations within these wetlands were not enforced at the town level; this would make the town more effective. She asked for comments or questions from the public and the board. Councilman Huestis supports the proposal. Supervisor Fleming suggested adjourning the public hearing allowing anyone who could not attend to submit comments.
