At 7:05 p.m. Supervisor McGlasson called the meeting to order with the Pledge of Allegiance.

Approve Memorandum of Understanding with Putnam County - Tabled

Resolution #390 Acceptance of Conveyance of Property from Putnam County

Highway Superintendent Othmer said the PC Legislature voted last week to convey the land to the Town of Kent for \$1.00. The procedure is for the town board to accept it by resolution and the deed will then be turned over to the town. This is the final piece to the puzzle. Town Counsel said there is one condition that the land always be used for a public purpose otherwise it reverts to the County. Sue Kotzur asked if the 9 acres is being taken off the tax rolls. Town Counsel replied it was owned by Putnam County and was not on the tax rolls. Sue Kotzur asked if it was presented to the County as a road and asked if the composting is a secondary use of the land. Highway Superintendent Othmer said it was given to the Highway Department for Highway Use. On a motion by Councilman Tompuri

WHEREAS, by tax deed the County of Putnam acquired title to certain parcels of land located in the Town of Kent and designated as Tax Map Nos. 22.-2-28 and 22.-2-29 (the "Property"); and

WHEREAS, the Property is adjacent to Town of Kent Highway Department facilities and, according to Richard Othmer, Town of Kent Highway Superintendent, would be a tremendous asset to the Town Highway Facilities; and

WHEREAS, the County is willing to convey the subject parcels to the Town of Kent for its Highway Department purposes; and

WHEREAS, pursuant to Putnam County Code Section 31-8, by Resolution No. 251 dated December 5, 2023, the Putnam County Legislature approved the conveyance of the Property to the Town of Kent for use by the Highway Department; and

WHEREAS, the Town Board of the Town of Kent wishes to accept the conveyance of the Property for use by the Highway Department;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby accepts the conveyance of the Property from Putnam County for use by the Highway Department understanding that should the Property not be used for a public purpose, it will revert back to the County; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Kent hereby authorizes the Town Supervisor to execute any and all documents necessary to give effect to this resolution. Motion carried unanimously

Resolution #395 – Insurance Renewal

WHEREAS, certain insurance policies for the Town of Kent held through NYMIR are in need of renewal; and

WHEREAS, the Town Board of the Town of Kent is in receipt of a Property and Casualty Proposal for the Town of Kent from the Brown & Brown (the "Proposal"); and

WHEREAS, the Proposal details all coverages and limits for NYMIR policies renewing on January 1, 2024, a copy of which Proposal is annexed hereto and incorporated by reference herein; and

WHEREAS, the Town Board of the Town of Kent wishes to renew the above policy consistent with Option 2 for a term of 2 years at a cost of \$167,155; and

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent approves and accepts the Proposal from Brown & Brown to renew its insurance policies consistent with Option 2 in an amount not to exceed \$167,155 for a term of 2 years; and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized and directed to execute any and all agreements and other documents necessary to give effect to this Resolution, consistent with the terms hereof, all in form satisfactory to the Supervisor and the Town Attorney.

Resolution #396 – Authorizing Submission of a Grant Application to the NY Department of Transportation for the 2023 Transportation Alternatives Program & Approval of a Local Match Contribution

On a motion by Councilwoman Campbell Seconded by Councilman Tompuri

WHEREAS, the Town of Kent seeks to implement pedestrian safety improvements within the corridor of Route 52 from Clapboard Ridge Road to Sybil's Crossing in the Town of Kent; and

WHEREAS, the New York State Department of Transportation ("NYSDOT") Transportation Alternatives Program ("TAP") grant provides federal aid for projects related surface transportation safety and mobility improvements; and

WHEREAS, the Town of Kent has opted to submit an application to the NYSDOT TAP grant (#DOT01-TPCM23-2023-00037) for the Town of Kent Safety Improvements which comes at a cost of up to \$ 8,000,000; and

WHEREAS, the NYSDOT TAP grant will fund up to 80% of the total project cost, up to a maximum of \$5,000,000, and requires a local match of at least 20% of the total project cost; and

WHEREAS, the Town of Kent is requesting a grant in the amount of \$5,000,000 (80%) and is committed to funding the remaining amount, up to \$3,000,000, through local funds.

NOW, THEREFORE BE IT RESOLVED, that the governing body of the Town of Kent (Town Board) has authorized the submission of this application and has approved the required local match.

BE IT FURTHER RESOLVED that the Town Supervisor is authorized to execute the grant agreement and the signature of the Town Supervisor constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement. Motion carried unanimously
