TOWN BOARD MEETING JUNE 20, 2023

A regular Town Board Meeting was held on Tuesday, June 20, 2023 at 7:00 p.m. at the Kent Town Hall, 25 Sybil's Crossing, Town of Kent, New York. To see the full meeting visit the Town of Kent's website at www.townofkentny.gov under Video's on Demand.

At 7:00 p.m. Supervisor McGlasson called the meeting to order with the Pledge of Allegiance.

Natural Resources Inventory

Councilwoman Campbell expressed excitement about the Natural Resources Inventory presentation. She said the CAC made a commitment years ago to inventory and discover the resources in town. The goal was to conduct a Natural Resources Inventory a planning document that would be resource for all kinds of planning activities within the town. It began as the Kent Nature Almanac where citizens sent in their observations. She said funding was successful from the NYSDEC Hudson Estuary Program in part due to the biodiversity component that was done by Bill Buck and Beth Herr. She introduced Gretchen Stevens from Hudsonia a non-profit organization based out of Bard College. Ms. Stevens has been working with the NRI Steering Committee for over a year and was assisted by Chris Graham of Hudsonia and Christine Vanderlan from DEC's Hudson River Estuary Program. She presented and reviewed a slide show please see attached. She anticipates the next draft of the NRI for public review and review by the town board, planning board and other agencies including the public review which will be crafted by a professional designer for the final document. She said additional grant funding will be sought for the design and layout work. William Volckmann Chairman of the CAC explained the NRI is an exciting project which began when he took on chairmanship and identified in the Kent Comprehensive Plan as a priority to pursue. It is a fundamental land use planning tool used in a variety of ways. He anticipates receiving further grant funding and publicizing the NRI in a book form and web version. Councilman Boyd thought it a great project, he deals with ground water for his business and having this is awesome.

BIOLOGICAL RESOURCES

The term "biological resources" encompasses all the living organisms, biological communities, habitats, and ecosystems that constitute the living landscape. Although we discuss them separately in this section, the types and condition of biological resources in Kent are inseparable from physical features such as bedrock, soils, water, climate, and landscape setting.

Information about the plants, animals, and habitats of the region can be obtained from several easily-obtained literature sources. The <u>Biadirersity Assessment Manual for the Hudson River Estimate Cantilar</u> describes many of the habitats of the region, some of the plants and animals of conservation concern that use those habitats, and principles and measures for effective conservation. <u>Evalugical Cannaunities of New York State</u> describes natural communities throughout the state. NYSDEC has sponsored two editions of the <u>New York Breeding Bird Atlas</u>, for the periods 1980-1985 and 2000-2005, and the next edition (2020-2025) is in progress. NYSDEC also sponsored the <u>New York Dragontly and Daniselly Survey</u> (2005-2009). The last three documents map the results of focused surveys by biologists and trained volunteers.

The New York Natural Heritage Program (NYNHP) has surveyed many sites throughout the state to discover new occurrences and to confirm past records of rare species of plants and animals, and natural communities of especially high quality. But much of the biological diversity of the Town of Kent and the region as whole is yet unsurveyed and unknown. A question was asked by Kathy Doherty if the town takes over the paper road do they become town roads. This item was tabled.

Resolution #192 - Authorization to Offer Highway New Pick-Up Body for Sale to Lake Carmel Park District

On a motion by Councilman Boyd Seconded by Councilman Ruthven

WHEREAS, by email dated May 31, 2023, Richard T. Othmer Jr., the Highway Superintendent, has recommended that a new pick-up truck aluminum body be sold to the Lake Carmel Park Department for a price of \$3,580.00 (the "Pickup Body"), the cost paid by the Highway Department for the aluminum pickup body; and

WHEREAS, the Town Board wishes to authorize the Highway Department to sell the Pickup Body to the Lake Carmel Park District for \$3,580; and

WHEREAS, Section 103(6) of the General Municipal Law exempts from competitive bidding purchase contracts surplus and second-hand supplies, material, or equipment from the federal government, the State of New York, or from any other political subdivision, district, or public benefit corporation; and

WHEREAS, in accordance with the Town's Procurement Policy and the General Municipal Law, the Town Board wishes to authorize the Lake Carmel Park District to purchase the Pickup Body as further detailed above;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby authorizes the Highway Department to sell the Pickup Body to the Lake Carmel Park District for \$3,580.00; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Kent hereby approves the purchase of the Pickup Body by the Lake Carmel Park District for a purchase price of \$3,580.00.

Motion carried unanimously

Budget Transfers - Bonds - Tabled

Supervisor McGlasson explained this is a new bond for paving. During the budget process it was agreed upon that half would be bonded. The board was in agreement that further discussion was needed.

Resolution #193 - Authorizing Replacement of Video Server Upgrades

WHEREAS, according to Richard Harris, Town of Kent Information Technology consultant, there is a need for a new video server for the Town of Kent (the "Server"); and

WHEREAS, pursuant to the Town's Procurement Policy Mr. Harris requested three quotes for the Server and received two quotes in response to the request; and

WHEREAS, the Town wishes to accept the proposal of DNR Laboratories in the amount of \$18,038 for the Server.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby authorizes and approves the purchase of the Server at a cost not to exceed \$18,038 from DNR Laboratories; and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized and directed to execute any and all agreements and other documents necessary to give effect to this Resolution, consistent with the terms hereof, all in form satisfactory to the Supervisor and the Town Attorney.

Resolution #194 - Approve Allocation of American Rescue Plan Act ("ARPA") Funds

Seconded by Councilman Tompuri

WHEREAS, the American Rescue Pan Act of 2022 ("ARPA") provided fiscal recovery funds to county governments, as well as other forms of government, pursuant to US Department of Treasure Compliance and Reporting Guidance, for the purpose of alleviating the fiscal stress caused by the COVID-19 pandemic, and the Town of Kent has received funding from ARPA; and

WHEREAS, the Town of Kent Public Library is in need of computers, programs and other materials to be used to improve the services the Library provides to Town residents; and

WHEREAS, the Town Board wishes to allocate the sum of \$46,444 to the Library from ARPA funds it has received;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Kent hereby approves the sum of \$46,444 for the Kent Public Library for the purchase of computers, initiation of programs and other materials for its general purposes;

BE IF FURTHER RESOLVED, that the Town Board of the Town of Kent hereby ratifies and approves any actions previously taken to give effect to this Resolution.

Resolution #195- Constructing Fencing Around Town of Kent Police Department ("ARPA")

WHEREAS, there is a need for additional fencing around the Kent Police Department grounds; and

WHEREAS, consistent with the Town's Procurement Policy, the Town of Kent Police Department requested quotes for the construction of fencing around the Kent Police Department located at 40 Sybil's Crossing, Kent Lakes, New York 10512; and

WHEREAS, the Town Board wishes to approve an amount up to \$31,360.00 for the constructing of fencing around the Kent Police Department to be paid from ARPA funding;

NOW THEREFORE, BE IT RESOLVED, the Town Board of the Town of Kent hereby authorizes the installation to construct the fencing around the Kent Police Department for an amount not to exceed \$31,360.00; and it is

FURTHER RESOLVED, that the Town Board of the Town of Kent hereby authorizes and directs the Supervisor to execute any and all documents necessary to give effect to this resolution. Motion carried unanimously

Town Counsel Tagliafierro explained in adopting the Local Law regarding excavation the town has to do a SEQRA review and the town board is going to appoint itself as the lead agency for SEGRA purposes.

Seconded by Councilman Tompuri

WHEREAS, The Town of Kent Town Board (hereafter "Town Board") desires to consider and adopt Local Law ____, (the "Action") amending Chapter 63 (Excavation and Mining) of the Town of Kent Town Code as follows:

- 1) Provide for a prohibition on Mining and provide a permit process for excavation within the Town of Kent.
- 2) Provide for specific exemptions to the aforementioned excavation permit.
- 3) Provide the application process and requirements for obtaining an excavation permit.
- 4) Provide for enforcement proceedings in the event that an excavation permit is not applied for and obtained; and

WHEREAS, the Town Board is directly undertaking the Action and as the only involved agency, desires to serve as Lead Agency for the environmental review of the Action pursuant to the New York State Environmental Quality Review Act (SEQRA) 6 NYCRR Part 617.6; and

WHEREAS, the Town Board, as Lead Agency, has identified and intends to classify this Action as a Type 1 Action pursuant to 6 NYCRR § 617.4 of the Regulations and the Town Board has caused the preparation of a Full Environmental Assessment Form (FEAF) for review of the Action; and

NOW, THEREFORE, BE IT RESOLVED, pursuant to the applicable standards of 6 NYCRR § 617, the Town of Kent Town Board concludes that it is the appropriate agency to serve as, and declares itself Lead Agency for the environmental review of the Action; and

BE IT FURTHER RESOLVED, pursuant to the applicable standards of 6 NYCRR § 617, the Town of Kent Town Board, as Lead Agency classifies the Action as a Type 1 Action; and

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately. Motion carried unanimously

Resolution #198 - Accepting & Releasing Erosion Control Surety Bond & Escrow for Inspection Fee

Public Comment

Sue Kotzur asked the status for the automatic doors for Town Hall. Supervisor McGlasson said the parts that are needed are on back order. Mr. Kevin Murray of the NY Citizens Audit was here two weeks ago and he distributed a package of the audit of the election. He asked if it has been reviewed. Councilman Boyd read it and thought they were not in a position to stand or not stand behind it. He thought they were not going to do anything with it. Councilwoman Campbell said it is not town business, the town has no control over elections and therefore asked to adjourn to executive session. Mr. Murray disagreed he thought it individual business, town business, county, state and federal business. He said if we do not have fair and honest elections we do not have a republic the country is at stake. He said so far17 towns in NYS have adopted the resolution. He said it is an 8 to 10 minute presentation to explain who NY Citizens are. Supervisor McGlasson said one board member is not present, they will discuss this further and get back to him. Councilman Tompuri asked the goal of his organization since the town board does not have control over the election process. He thought even if the board adopted a resolution he would have to go the state. Mr. Murray disagrees he said if we get enough towns in each county we can get the counties to put pressure on the state. He said it is a ground up goal. Councilman Tompuri said there is no backbone to the resolution he thinks the state legislator is going to do whatever they want. Mr. Murray thought at least it would be on the record.
