Resolution #342 - Public Hearing - 2024 Budget


On a motion by Supervisor McGlasson Seconded by Councilman Tompuri Resolved: The public hearing on the 2024 Budget was opened. Motion carried unanimously

Director of Finance Yulia Kelly went through a power point presentation on the budget. (Attached) She explained the majority of the tax is school, followed by the town and county. She said the school's portion increased by over 74%, displaying the changes in the tax rates which have gone up where the town and county have stayed level. She explained the Preliminary Budget reflects a 3.81% increase for the General and Highway Funds. Explaining it may look like we are over the cap but we are just under and not breaking the tax cap. She said required mandated retirement contributions have increased by 15% and 4% respectively and overall increase in payroll as well. She said health insurance has increased over the last 8 years by \$900,000.00. Supervisor McGlasson asked for comments or questions. Kathy Doherty asked why the Highway Department is increasing by 4%. Yulia Kelly replied health insurance costs, retirees and new hires as well as anticipated contractual obligations for unsettled contract for teamsters. Kathy asked if everyone is getting a raise. Supervisor McGlasson replied 2%. Kathy asked what business investment property is? Yulia replied that demonstrates all the exempt properties and shows if they were not. Kathy asked if the franchise fees for Comcast and Verizon does not include the cell towers and asked what page that is on and the budget. Yulia replied \$155,000 in revenue. Kathy asked about page 8 refunds prior years expenditures is that a transfer for Ryan's Field lights? Yulia replied no, if there were checks or vouchers written in prior years and are no longer outstanding liabilities we recognize it as revenue in the current year. Kathy asked about gifts and donations. Yulia replied if anyone donates for recreation. Kathy asked if we still have DARE. Yulia replied we do. Kathy said you have nothing for ARPA revenue for 2024. Yulia replied it will be recognized it is in deferred revenue in the liabilities whatever we spend will be recognized then. Kathy asked about contingencies up to \$77,000. Yulia replied it is an anticipated contractual settlement with whatever teamsters are part of the general fund, municipal repairs and parks employees. Kathy asked about Parks Contractual page 22. Yulia replied some of that is Ryan's Field work that is covered by ARPA money from the county. Kathy asked about Stormwater Contractual it went from \$205,000 down to \$10,000. Yulia replied it is what we spent on a specific grant. Kathy asked if the sale of scrap for Lake Carmel Sanitation or Highway. Yulia replied there are two different lines they each have their own. Kathy asked about interfund transfers for \$700,000. Yulia replied coming from the General Fund for Highway's Debt service. Kathy asked about contingency personnel services \$119,000. Yulia replied for contractual settlements. Kathy asked about the jump in the Sewer district. Yulia replied it has been \$110,000 which included the portion the town pays to Kent Manor plus our fees we pay directly to vendors for maintenance, in the last year the Kent Manor was \$100,000 plus. Kathy said Shawn was looking into that. Councilman Boyd replied he was told we would receive a breakdown and have not. Kathy asked about total fund G is that the lawsuit money. Yulia replied yes. Kathy asked about Lake Carmel Park District total fund E expense and total fund SP1. Yulia replied that is the total expense for the district and how much fund balance is used to balance the budget.


Town of Kent 2024 Preliminary Budget




Tax Dollars Distribution




Changes in Tax Rates



Changes in School Tax Levy




Changes in Tax Levy of Nearby Iowns






Retirement Contributions




Health Insurance



Sanitation Contractual




Utilities Costs

Sue Kotzur said she was at a budget meeting and it was mentioned about a purchase she asked if the 4% is for a purchase. Yulia replied it was the estimated increases in salaries plus health insurance and retirement contribution, no new equipment. Sue said the Kent Recycling Center is in the budget and wants it known their funds are theirs and separate from the town's budget. Julie Boyd noticed throughout the budget estimated projected projects that were not made why would we still project the same amounts. Yulia explained you are seeing year to date numbers. Julie asked how the police fines are increasing so much. Yulia explained they are not fines but fees that they receive reimbursements for crime reports, various things. She said the Police Chief gave the estimate for the budget. Julie asked on page 5 interest income. Yulia explained the past few years the rates were nominal but the rates are now 4 and 5%. Julie asked about page 7 Health and Dare and Federal Aid is that something we normally get income on. Yulia replied yes we do. Julie asked on page 11 Municipal Court part time. Our actual is \$8,445 and projected to go up to \$86,000. Yulia said some of the salaries in the actual will be reclassified at the end of the year because they are in the full time personnel services code instead of the part time. Julie said so if she sees the contingencies on personnel services in any of the departments that is for the teamster labor negotiations. Yulia replied yes. Julie suggested the Air B & B Hotel Tax, she said there are a lot of people renting in Kent, let's get some of that tax dollars. Supervisor McGlasson replied that is on their radar. She explained the next town board meeting will be November 14 instead of November $21^{\rm st}$. The 2024 Budget will be open until that night.

Public Hearing - Local Law # /2023 Soil Removal and Excavation

Supervisor McGlasson explained this has been going back and forth for years. She thinks we have a final version, the notes have been reviewed and asked for comments from the board. Councilwoman Campbell said the version in the backup shows the changes that were made in red, in response to comments a clean copy will be submitted after adoption. Supervisor asked for public comment.

Mr. Neil Alexander a partner of Cuddy & Feder, representing Kent Country Square said the board has received many letter and comments from his colleagues and consultants about this law and their submission in August. He said he taking a look at the law and wanted to raise new concerns. He is concerned how the law intercepts with Federal Land use policy particularly the Telecommunications Act of 1996 and the 150 day shock clock. He doesn't know how an applicant pursuing a cell tower can make it through the law and the shock clock. He thinks the average land disturbance of 10,000 sq. feet is tight, most towers are up a hill and require grade changes. He added another Federal Fair Housing Policy. He does not know how you can build a multi-family housing project on a piece of property for work force housing, for a DHCR supported project under this level of restricted amount of disturbance. He said RLUIPA which is religious land use policy, if Watchtower wanted to build a large facility in town as an example they are religiously protected, you cannot burden a religious entity to practice and establish themselves under the first amendment and under RLUIPA. He said you should look at NY Law and the way your Agriculture exemptions are written. New York is a right to farm state, he thinks the definition of a farm operation, what is a commercial horse boarding operation, commercial equine operation you would not be able to allow them to do what they do with the restrictions. He said this building and complex would not meet the law. He knows you have been looking as this a long time, a moratorium doesn't have to continue to work on a law. He thinks there is an appropriate and important policy behind this, not just fighting off regulation. He recognizes there are goals but thinks this may be to blunt force an instrument to accomplish those important policies. He thinks there is a need for a fiscal study to accompany this. This law applies the same to a 10 acre parcel as to a 100 acre parcel or 25 acre parcel. You have said if you have a 10 acre commercial property and a 100 acre commercial property they are worth the same because the amount of disturbance you can undertake is the same and therefore the project you can build on both is capped out the same therefor worth the same. He would file a

tax certiorari immediately upon the adoption of this law because the develop ability is completely constraint. It means your commercial tax revenue will shift, you're trying to stay under the tax cap it will land on your residents. He said the school district has decreased by 15% in enrollment in the past decade looking at filings from NYS Education Dept as per your school district, another 10% decline in the next 5 years. He said your school enrollment is going down but the fixed costs stay the same and your about to shift the fiscal impacts from commercial to residential. He said they have been waiting and complaining about the law, he thinks the moratorium can lapse and there are ways to work through it. He thinks it to tight, to restrictive, there are other ways to accomplish your purpose and goals. He thinks there are other ways for the regulated community to comply and meet your expectations without the chilling effect he is concerned the law will have in its current form. He noted from the last meeting you were not voting and wanted to posit these thoughts and hopefully a dialogue on them to work through some of the issues. He explained the law does not allow for an equine facility that could bring in jobs. He asked how it intercepts with your SPEDES permits that lasts for 5 years. He said a lot of great work has been done but it almost trumps your whole zoning code. It has made development chilled. He thinks about what the watershed regulations did for the ability for economic development in town and how the businesses were effected. He is concerned this will stop other business being able to come and will shift all from the commercial side of your budget to the residential. He thanked the board for listening he would like to work through the issues and concerns and not an attempt to get around to push off regulation but right sized.

Julie Boyd asked the board to change the few words circled in blue on the draft, page 2 from the earth and on page 10 K 13. A. there should be no or. She thanked the board for their hard work she thought we did not have to have this second hearing it was courtesy for those in the public that have worked for years. She thought this would be it.

Councilwoman Campbell explained we voted to pursue DOT Tap program funding for sidewalks along Route 52 in the commercial corridor. To apply we need an engineer to prepare a diagram and stamp on the application. The engineer that does this is not allowed to do the rest of the design work unless they comply with a certain procedure the NYSDOT requires. Under their local design services agreement program in Region 8 there are 16 engineering firms that are prequalified. We need to do that prequalification process now as it will be difficult to get an engineer to agree to what is needed for the application if they are unable to do the project. Most municipalities solicit the companies on the list asking if they are interested, we then review the pre-qualifications and select a firm. It will cost under \$4,000.
