Mr. & Mrs. Giannone residents of Putnam Drive, for twenty years, love living here; they asked the board for help with the speeding on their road. They have repeatedly called the Kent Police to stop the speeding on Putnam Drive, they do respond, they leave and it continues. They have a hard time getting in and out of their driveway and checking their mail. She said the school bus stops in the middle of Tuxedo because if she doesn't the cars will fly around her. She passed a picture of their 7 year old Beagle named Hunter that was killed by a speeding car and their child had to witness this in front of their own home. She said something needs to be done, a stop sign, a speed bump, flashing lights, signs showing they have children, pets, and people walking in their neighborhood that they no longer feel safe in. She said their son was diagnosed with Teret Syndrome, anxiety and has trouble sleeping; Hunter took the place of them and slept with him on a daily basis helping him get through the night. Over the years their son's issues have been almost invisible because of this dog. She explained the devastating of seeing their dog crushed in front of their home. He was not a normal size Beagle he was 48 pounds, a sized dog that should have been seen if he wasn't speeding. She said the town is responsible that this never happens to another family. Supervisor Fleming asked what they thought would work. She replied a speed bump and flashing lights. Mr. Geone said they are not doing 30 but 60 mph. Police Chief said as mentioned he suggested speaking with the town board and the Highway Superintendent to find a solution. Councilman Ruthven suggested placing an officer there tomorrow to give out tickets. Councilman Ruthven recalled stop signs not being a great idea to stop speeding, he asked if we could come up with options to mitigate speed on a road like this so that the town board can decide to take action and implement.
