On a motion by Supervisor Fleming Seconded by Councilman Denbaum Resolved: The Town Board opened the meeting and adjourned to Executive Session at 6:00 p.m. to discuss the matter leading to the appointment of a particular person or corporation and pending litigation. Motion carried unanimously

Resolution #198 - Adjournment

On a motion by Councilman Huestis Seconded by Councilman Chin Resolved: Executive session adjourned at 7:15p.m. Motion carried unanimously

Supervisor Fleming explained the board had an executive session; there were no votes taken.

<u>Pledge of Allegiance</u>- At 7:20 p.m. Supervisor Fleming called the Workshop Meeting to order with the Salute to the Flag.

Workshop Meeting

Annual Stormwater Presentation

Bruce Barber, the Stormwater Wetlands and Lake Consultant gave the annual presentation to comply with the Town's Stormwater MS4 permit requirement with the NYSDEC. The town entered into this agreement in 2003, in addition this year the town is subject to an interim progress report in how we are dealing with phosphorus. There are six minimum measures which he went into briefly. The full report will be available on the Town of Kent Website.

Anti- Sanctuary Town

Supervisor Fleming explained this is the third time this has been on the agenda for discussion and no consensus on how to proceed has been made. She read both proposed resolutions. Sheriff Don Smith thanked the board for allowing him to speak, he was asked by Legislator Toni Addonizio to speak not to advocate for any particular position but rather as a resource. In 2006 he hosted a state wide conference on this subject. Since then he continues to work on this issue. He explained how he and most in law enforcement have taken an oath to enforce the Laws of the Constitution and the State of New York. He explained most are concerned about criminal illegal immigrants. He said being in the country illegally is a civil violation of immigration law. Illegal aliens who have committed felonies and multiple misdemeanors are often allowed to stay, offend again making it less safe. He said Putnam has not been immune. He explained at the Putnam County Correction Facility is where the reporting is done, they report to ICE. Everyone, those detained, victims, and witnesses are treated with respect and dignity. He said it is the responsibility of government at every level is to keep the people safe. He thinks it is important for law enforcement to share and work together as a team. Supervisor Fleming thought the resolution proposed by Councilman Denbaum would have a chilling effect on any immigrant no matter what their status was of reporting a crime. They are excluded from protection from our police department. She thought the third paragraph, we will assist, we already do that no matter who asks. As the Sheriff stated we are not responsible for detention, and is a false statement, to say we are going to do this when it is not something we do is puffing. She said we do not need this resolution, we follow the law. She spoke to Sonia Thomas of ICE; she said ICE would never request that we provide them with immigration information. A number of emails were received opposing the resolution; residents spoke at the last meeting feeling it unnecessary. She does not think it is the job of the town board to make inaccurate political statements, she urged the board to let this be the last time this is discussed. Councilman Denbaum disagreed; he believes there is a lot of effort being made to derail the resolution. He thinks it is a hot topic throughout the state and country. The resolution points to criminal illegal immigrants. He is going to make a motion and ask for a second. He put what he believes on paper, he has received letters of support and opposition. He is satisfied with the resolution presented and does not want to change it. Councilman Chin said the intent of the resolution is not to victimize a victim, these illegal aliens hide behind those here legally. He believes being proactive will make residents feel safe. Councilwoman McGlasson stated we want to take a stand on how the board feels.

<u>Public Comment</u> – Mr. Papas a resident of Kent stated his point this evening is not about the previous discussion or the anti-sanctuary resolution. Based upon the discussion maybe the town board can take

a look at the community policing activities of the Police Department, evaluate the policies and procedures to try to get the Police Department to not wait until something gets to them but to see what the current best practices are and to be pro-active, ways to prevent crimes. He proposed the town board task the Kent Police Department to evaluate that.

Therefore be it resolved that the Town of Kent shall assist and cooperative with any investigation, detention or arrest by an agency enforcing federal immigration laws and if requested disclose information regarding the citizenship or immigration status of any person to said agency.

Be it further resolved that the Town of Kent Chief of Police will still be vested with any and all authority and discretion necessary to cooperate with investigation
