# Presentation by NYS Office of Real Property Tax Services

John Wolhan from NYS Office of Real Property Tax Services was present to give a certificate to Gary Link, the Supervisor and the Town Board. He said the certificate is known as Excellence in Equity for 2014, recognizing the work the Town of Kent has done to maintain an equitable assessment roll. He said the Town of Kent has over 7,000 parcels and since 2001 the Assessor's Office has been assessing those properties on an annual basis. Other than a break in 2008 the Town has maintained a level of assessment of 100%, which means the town's assessments reflect current market value at 100% as of the annual valuation date required by law for each roll. Each roll is a snapshot in time of value, essentially to the extent that the municipal roll reflects current value. The assessment roll is used to fund county, village, town, school, and special district taxes. People are only paying their fair share, no more, no less which is the cornerstone of good local government. Unfortunately not every municipality throughout the state does this. He recognizes the efforts made by Gary and his clerk Diane. He thanked the Supervisor and the Town Board for their support allowing Gary to do this. The certificate is humble but the thank you and appreciation behind it is not. He presented him with the certificate.
